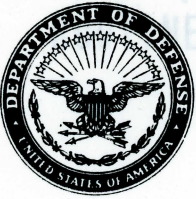

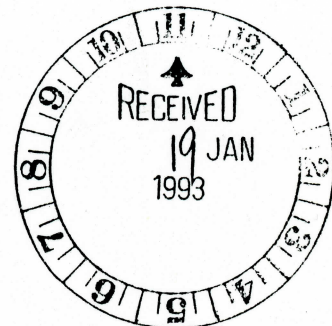

ALL PHOTOGRAPHS TAKEN ARE INVENTORIED AND MAINTAINED BY THE ROLL AND FRAME NUMBER LOGGED DURING THE COLLECTION PROCESS. THIS MESSAGE PROVIDES INITIAL ANALYSIS OF 3 PHOTOGRAPHS CORRELATED TO REFNO 1329. THESE PHOTOGRAPHS ARE IDENTIFIED AS ROLL 1/FRAME 7, AND ROLL 4/FRAMES 20 AND 22.

2. ROLL 1/FRAME 7 IS A PHOTOGRAPH OF ITEMS AS LISTED BELOW:

A. ONE ENVELOPE ANNOTATED IN VIETNAMESE WHICH TRANSLATES TO READ "MORRISON, JOSEPH C.; FRANCISCO; F4-D, 25-11-68; QUANG BINH". THIS INFORMATION CORRELATES TO THE FULL NAME FOR REFNO 1329-1-02, THE LAST NAME ONLY FOR REFNO 1329-1-01, THE CORRECT TYPE OF AIRCRAFT, THE DATE OF INCIDENT AND THE PROVINCE OF INCIDENT ASSOCIATED WITH REFNO 1329.

B. TWO AIR FORCE MILITARY IDENTIFICATION CARDS (FRONT AND BACK) FOR LT SAN DEWAYNE FRANCISCO, SERVICE NUMBER: FV3193610, AND MAJOR JOSEPH C. MORRISON, SERVICE NUMBER: FRS3340. THESE ITEMS CORRELATE TO THE RANKS, FULL NAMES, AND SERVICE NUMBERS FOR REFNO'S 1329-1-01 AND 1329-1-02.

C. A US GOVERNMENT MILITARY DRIVER'S LICENSE FOR MAJOR JOSEPH C. MORRISON. THIS INFORMATION CORRELATES TO THE RANK AND FULL NAME FOR REFNO 1329-1-02.

D. AN INTERNATIONAL VACCINATION CARD WITH NO NAME LISTED. THIS ITEM DOES NOT PROVIDE ENOUGH DATA TO CORRELATE.

E. TWO LIFE PRESERVER INSPECTION FORMS. THESE ITEMS DO NOT PROVIDE ENOUGH DATA TO CORRELATE.

F. ONE TWENTY DOLLAR BILL. NO UNIQUE IDENTIFICATION MARKS ARE VISIBLE.

G. ONE 12 INCH RULER USED FOR COMPARISON OF OTHER ITEMS IN THE PHOTO.

3. ROLL 4/FRAMES 20 AND 22 DEPICT CLOSE-UP IMAGES OF VARIOUS ITEMS IDENTIFIED IN ROLL 1/FRAME 7. NO FURTHER IDENTIFICATION OF ANALYTICAL CLUES ARE VISIBLE IN THESE VIEWS.
