RESOLUTION APPROVING LOAN AGREEMENT

WHEREAS, the Central Washington State College has heretofore filed with the United States of America, an application for a loan to provide student housing at Central Washington State College, Ellensburg, Washington, Project No. CA-Wash-90(D), and the United States of America, acting by and through the Secretary of Housing and Urban Development, has tentatively offered to make the requested loan and has transmitted for consideration a proposed Loan Agreement; and

WHEREAS, said Loan Agreement has been duly read in open meeting, fully considered in accordance with all pertinent rules of procedure and legal requirements, and made a part of the records of the Board of Trustees of Central Washington State College; and

WHEREAS, it is deemed advisable and in the public interest that said Loan Agreement be approved and its execution authorized;

NOW, THEREFORE, be it resolved by the Board of Trustees of Central Washington State College that said Loan Agreement be and the same hereby is approved without reservation or qualification.

BE IT FURTHER RESOLVED that MARY ELLEN DAVIS, the Chairman of the Board of Trustees of Central Washington State College,

be and she is hereby authorized to execute said Loan Agreement, and JAMES E. BROOKS, the Secretary thereof, be and he is hereby authorized to attest the execution of said Loan Agreement.
