MOTION NO. 3610: Mr. Caron moved, seconded by Mr. Garcia, to accept the resignation of Donald P. Tompkins, Associate Professor of Art, effective at the end of fall quarter. The motion carried.

Resolution Nos. 71-11 and 71-12--Regarding Fees

MOTION NO. 3611: Mr. Caron moved, seconded by Mr. Frank, to approve Resolutions 71-11 and 71-12 (with revisions). The motion carried.

During the preceding discussion the board asked that the following revisions be made to Section No. 3 of Resolution No. 71-12: that the words "adopt in the name of" be deleted and the words "make a recommendation to" be substituted, and that following the word "College", the words "for the adoption of" be added to make Section No. 3 read: "After hearing all interested parties, to make a recommendation to the Board of Trustees of Central Washington State College for the adoption of rules and regulations consistent with the spirit and intent of those adopted in Resolution No. 71-11."

Hearing on Human Rights Policy

The Chairman opened the hearing on Human Rights Policy.
pr. Brooks noted that although work on the policy has covered a
period of approximately two years, and involved administrators,
faculty and students, the policy has not been widely circulated on
campus and he suggested the hearing be continued to the next meeting
of the board so that this may be accomplished.

Dr. Harsha, Dr. Lowther and Dr. Yee, original members of the Committee who drafted the Procedures, Rules and Regulations section of the policy, spoke briefly. Mr. Frank asked for the definition of the term "national origin." Mr. Milam will research this. It was suggested the term "ethnic" origin might be used rather than "national" origin.

Mr. Mardi Sheridan asked that the Human Rights Policy state explicitly that a professor would not be denied employment because of his political beliefs.

After further discussion in which members of the audience participated, the Chairman continued the hearing to the next board meeting on November 12.

Resolution No. 71-10--Emergency Rules and Delegation of Power Regarding Formal Hearings

MOTION NO. 3612: Mr. Frank moved, seconded by Dr. Brain, to adopt Resolution No. 71-10--Emergency Rules and Delegation of Power Regarding Formal Hearings, with revisions. The motion carried.

The revisions included (a) deletion of the words "faculty member" on page 2, first complete paragraph, and substitution of the words "individual requesting formal hearing", (b) deletion of the words "adopt in the name of" in section 3, page 3, and substitution of the words "make a recommendation to", and (c) the addition of the words "for the adoption of" following the words "Board of Trustees of Central Washington State College" in section 3, page 3. (A complete copy of the resolution is on file in the President's office.)

A Proposed Revision to the Faculty Code, Section IX.E.

Mr. Milam presented a proposed revision to Section IX.E.-Procedure for Dismissal of Faculty Members for Cause, of the Faculty
Code. The revision was drafted at the request of the board who wish
to be relieved of the long hours of hearing established under the

present procedures. Dr. Brooks strongly recommended that the proposal be sent on to the faculty for consideration as a board proposal, with the request that the faculty respond to a need of the board.

MOTION NO. 3613: Mr. Caron moved, seconded by Mr. Garcia, that the meeting be adjourned. The motion carried, and the meeting was adjourned at approximately 11:00 p.m.
