FCSF 101 Skills for Marriage – Committee reviewed the revised course description and outcomes. Cynthia moved to not approve the course as submitted. Bobby seconded. Committee voted to not approve the course for general education.

FIN 364 Personal Finance – Janet reported that the course was approved by the Curriculum committee. Scott indicated that there was a 300 level course in the basics skills prior to 1997. However, the 75 credit rule was not in effect at that time. Duane suggested talking to department about putting it in basic skills. Scott indicated he would talk with his staff on the west side to see what the demand would be.
