STUDENT AFFAIRS

Proposed Changes in ASC By-Laws

MOTION NO. 3913: Mr. Frank moved approval of the proposed changes in the ASC By-Laws as presented by Roger Ferguson. The motion died for lack of a second.

The chairman suggested that the questions which had been raised by the board be reconsidered and that the proposed changes be resubmitted at the next meeting of the board.

ADMINISTRATIVE AFFAIRS

Administrative Exempt Salaries for 1973-74

Dr. Brooks presented two lists of 12-month employees for proposed salary increases. The first list included 12-month faculty-department chairmen, program directors, and librarians (exluding the dean). These twelve month employees are to receive the \$40 a month salary increase (originally approved by the state legislature to become effective February 1, 1973) and 6%. Merit additions may be made on September 1, 1973.

The second list, other Civil Service Exempt Employees, 12-month administrators, are to receive salaries based largely on merit. Most are to receive a 5 per cent cost of living increase which utilizes the \$40 a month increase which was approved by the state legislature to become effective on February 1, 1973. The average increase above present salaries (including the \$40) for this group is 7.5 per cent; this compares with the 9.1 per cent average increase the faculty is estimated to receive on September 1, 1973. Dr. Brooks pointed out that several vacant positions in administration were listed with no increase, which lowered slightly the average per cent received by the 12-month administrators.

MOTION NO. 3914: Mr. Frank moved, seconded by Dr. Brain, to approve the administrative civil service exempt salaries and the 12-month faculty salaries as presented. The motion carried. (A copy of the two lists are on file in the President's office.)

NEXT MEETING

It was agreed to have the next regular meeting of the Board of Trustees on September 14, 1973.

ADJOURNMENT

The meeting was adjourned at approximately 9:15 p.m.
