Approval of Agenda - The committee approved the agenda as written.

<u>Approval of Minutes</u> - The committee approved the November 15th minutes.

<u>Program Change</u> - Representatives from the Art Department talked to the committee concerning the overall program changes. K. Lewis agreed to email additional verbiage to clarify any concerns. The FSCC will review the change at the next meeting in January.

<u>Hold Policy</u> - The committee discussed the hold policy form and added "Must be approved by the Faculty Senate". R. Bransdorfer moved to approve the hold policy form and change to the CWU Policy, M. Wise seconded. MOTION PASSED.

Deadline for conforming – With the new definitions for majors, minors, certificates, and specializations, discussion took place as to when programs would have to conform to the new definitions.
