RECESSED


The Chairman recessed the meeting at approximately 1:15 p.m. to allow the members to go to lunch.

The Chairman reconvened the Executive Session at approximately 2:30 p.m. Proposed terms of employment were discussed. By unanimous agreement of the Board, Dr. Garrity was offered an annual salary of \$48,500, faculty rank, and benefits as outlined in the letter confirming appointment (see attached letter). Dr. Garrity asked for a few days to consider the Board's offer and agreed to respond to the Chairman by telephone by the morning of April 5, 1978. At approximately 3:30 p.m. Mr. Hogan, Dr. Garrity and Mr. Galbraith left the meeting. Mrs. Clifton, Mr. Munro, and Mr. Broughton discussed procedures for concluding the search process.
