NEW BUSINESS

Emergency Roof Repairs, Samuelson Union Building

MOTION NO. 5536: Mr. Galbraith moved, seconded by Mr. Case, to accept the construction work on State Contract #81-377, Emergency Roof Repairs, Samuelson Union Building, as complete for a total contract amount of \$34,377.69 plus Washington State sales tax from Yakima Valley Roofing, Co., Inc. Motion carried.

Faculty Leaves of Absence

MOTION NO. 5537: Mr. Case moved, seconded by Mrs. Clifton, that Erlice J. Killorn. Assistant Professor of Physical Education, be granted a leave of absence without pay for the 1982-83 academic year, time not to count towards seniority with the stipulation that the repayment condition in the May 27, 1980 Retraining Leave Contract not only remains in force, but is hereby extended one year after the expiration of the leave without pay period. Motion carried.

The motion was seconded by Mr. Galbraith and Mr. Munro and passed unanimously. The Chairman asked that the resolution be sent on to Mr. Broughton with the compliments of the Board.

Study Committee on Faculty Layoff

MOTION NO. 5550: Mr. Case moved that the Board of Trustees request Dr. Tolman and Dr. Garrity to use their offices and appropriate committees to review the current Code procedure effecting staff layoffs caused by financial exigency.

Discussion clarified the intent of the motion which would desire the faculty and the administration to use their experience and collective wisdom to make the study in order to help guide the Board in making further staff reductions. Focus of the study will be review of the process just used to see if any changes are necessary to improve its working smoothly and fairly. The review procedure would look specifically at whether or not the current Code would allow programmatic considerations to be made in any future personnel reductions. Further, the Board would ask that Drs. Tolman and Garrity report back to them in such timely fashion that the recommendations could have an impact on the Board's thinking concerning any imminent reductions.

The motion was seconded by Mr. Galbraith and carried.

The next meeting of the Board of Trustees was set for April 9, 1982.

MOTION NO. 5551: Mrs. Clifton moved, seconded by Mr. Galbraith that the regular meeting set for April 9, 1982 be canceled and that a special meeting be called for April 16, 1982 in Room 143, Bouillon Hall at 7:00 P.M. Motion carried.
