APPROVAL OF MINUTES

MOTION NO. 90-15: Mr. Tollefson moved approval of the minutes of the regular meeting of the Board of Trustees held October 12, 1990. Motion seconded by Mrs. Gould and passed.

CHANGES TO THE AGENDA

With the concurrence of the Trustees, Item VII-B, Proposed acceptance as complete the Energy Saving Project, Steamline Replace - Phase I (contract 2375), was deleted from the agenda.

REPORTS

Board of Trustees

Chair Woodhouse announced that the Board would recess between 12:00 noon and 12:30 p.m. for lunch, followed by a tour of the Geographic Information System lab, and that the meeting would reconvene in open session at approximately 2:00 p.m.

Dr. Woodhouse stated that the Board retreat originally scheduled to follow the meeting on November 30 has been rescheduled to follow the regular meeting of January 25, 1991, and all Trustees have indicated they would be able to attend.

President

President Garrity briefed the Board on his recent trip to Japan which he reported was a great success. He and Mrs. Garrity were accompanied by Dr. Kelly Ainsworth, Director of International Programs, and his wife, Pat.

President Garrity said that with regard to Shimane Prefecture, Central Washington University is looked upon with considerable fondness and respect. We have had a sister-university relationship with the national university in Matsue, Shimane University, and because of the former president of that university taking on the presidency of the Women's Junior College in Shimane, we have now signed a limited agreement to work with them, particularly in view of their efforts to become a four-year university for women. The president shared the document with the Board and said that the signing ceremony attracted great attention. Shimane prefecture is so impressed with what we are doing that two meetings with the governor were held while they were in Matsue. It is the governor's intention to visit CWU when he comes to the United States in June.

Elaborating on our Japanese program, the president told the board that Central this year has three students awarded Monbusho (Ministry of Education) scholarships, and said that previously it was unheard of for one institution to receive three such scholarships in a single year. While in Japan, the group met with current Central students there as well as CWU Japanese alumni who have returned home.

Provost and Vice President for Academic Affairs

No report at this time.

Faculty Senate

Dr. Charles McGehee, Chair of the Faculty Senate, reported that the Senate has created two committees which are now functioning to examine the structure of the curriculum and that of academic governance. It is hoped that a report from both will be available by the end of the year.

Student Government

No report at this time.

Association of Administrators

Association of Administrators Chair, Cheryl McKernan, said that the association had not met since the last Board meeting but would be meeting on December 12. In the interim, the association made a recommendation for the distribution of the January 1, 1991 6% salary increase which was 1/2 across the board and 1/2 for merit. The administrative salary group determined it should be distributed as 6% for merit. Some members of the Association expressed concern over the minimums set for positions on the salary structure and the president has agreed to meet with the association to answer questions.

NCATE

Provost Edington introduced the subject report saying that the nonrenewal of accreditation for Central's Teacher Education program by the National Council for Accreditation of Teacher Education (NCATE) had created a number of mistaken notions which needed to be clarified.

The NCATE program is participated in by less than one-half of the institutions across the United States. Though Central has had the approval of NCATE for a long time, in the process of seeking reaccreditation this year, some controversy arose. Provost Edington called on Dr. Jimmie Applegate, Dean, School of Professional Studies, and Dr. Donald Cummings, Dean, College of Letters, Arts & Sciences, to review with the Board the circumstances resulting in the nonrenewal of accreditation by NCATE.

Deans Applegate and Cummings provided historical information on the issues relating to Central's programs in teacher preparation, the CWU

self-study, and the visitation and subsequent report and action by the NCATE team. Lengthy discussion followed.

Chair Woodhouse requested that the Board receive further information on the subject and a followup report at the next meeting.

NEW BUSINESS

Establishment of a bank account for residence hall activities

MOTION NO. 90-16: Trustee Tollefson moved, seconded by Trustee Pitts, that the Board approve the establishment of a Central Washington University Residence Hall revolving checking account at the Security Pacific Bank to pay for expenses of the residence hall activities.

President Garrity explained that the residence hall accounts previously have been serviced through the CWU Foundation. The volume of activity is very high, but the amount of funds is relatively modest. The recommended action will result in the activities being transacted through the regular University accounts under the control of the Director of Auxiliary Services and the Director of Housing.

On call for the question, the motion carried.

Siting of State Archives Building on the Central Washington University Campus

The archives building will house the programs of the Central Regional Branch of ARCHIVES, CWU records, archival storage for CWU University Archives, and other archival records collections as agreed upon by the ARCHIVES. Space will be made available for practicum work and research by students and faculty of CWU as well as the general public.

Mr. Tim Eckert, the regional archivist, was present to answer questions from the Board. He told of the use of the archives and expressed his appreciation of the cooperation and good working relationship with CWU.

The site for the facility is located at the northwest corner of 14th & D Streets, near the CWU Library. The Interlocal Agreement between the Office of the Secretary of State (Division of Archives and Records Management) and Central Washington University is contingent and becomes effective upon approval by the Legislature of the state of Washington and the Governor of an appropriation to the Secretary of State for construction of the building.

MOTION NO. 90-17: Trustee Tollefson moved, seconded by Trustee Gould, that the Board of Trustees approve the siting of a regional historical records repository (Central Regional Branch of ARCHIVES) on the Central Washington University campus, and authorize execution of Interlocal Agreement. Motion carried.

Change to the educational benefits policy for Central Washington University staff and state classified employees

The action recommended will reduce the registration fee charged CWU staff members to \$15 based on actual cost experience during Fall Quarter, 1990.
