PERSONNEL REPORTS AND RECOMMENDATIONS

Emeritus Professor Status

Provost Tom Moore said that it was his pleasure to introduce faculty members who by their efforts have made this a better institution and who are now retiring. In reviewing the careers of the retiring professors, Provost Moore asked those present at the meeting, Professors Greatsinger and Madsen, to stand and be recognized. He then gave a brief overview of the years of service of each to Central Washington University.

Dr. Glenn A. Madsen's specialities are vocational and special education. In addition to his 24-year teaching career at CWU, he has also chaired and served on numerous committees, the Faculty Senate, and the Graduate Council, and has given unselfishly of his time to the local and state communities. Dr. Madsen was awarded the 1993 Distinguished University Professor for Public Service Award in recognition of his dedication to others.

Dr. Calvin G. Greatsinger came to Central in 1969 as an assistant professor of education with an emphasis in reading. Throughout his professional life, he has maintained his interest in the area of reading and has taught a full range of courses from the beginning of the developmental series for undergraduates, through courses in the graduate program. He has also served on many university and state boards.

As the capstone to a long and distinguished career, in 1994, Dr. Greatsinger was inducted into the International Reading Association Reading Hall of Fame for the state of Washington.

Professor C. Boyd Johnson joined the CWU faculty in 1982 with 24 years of experience in the business environment and six years in teaching. He taught primarily marketing courses at the Ellensburg, Lynnwood, and South Seattle campuses before his retirement in June 1994.

MOTION NO. 94-30: Trustee Sánchez moved, seconded by Trustee Woods, that in recognition of their long and distinguished service to Central Washington University, the title of Emeritus Professor is hereby conferred upon the following individuals, along with all rights and privileges of that title: Glenn A. Madsen, Professor of Education, Retirement effective end of 1994-95; Calvin G. Greatsinger, Professor of Education, Retirement effective end of Fall 1994; and C. Boyd Johnson, Associate Professor of Business Administration, Retirement effective end of 1993-94. Motion carried.

The Board congratulated the group, wished them well, and said they will be missed.

Distinguished Administrator Status

B. Dean Owens, Director of Career Planning and Placement, was recommended for Distinguished Administrator Status effective September 30, 1994. Mr. Owens was the senior member of the Student Affairs Staff whose office established an enviable placement record and has served well the needs of our students. For the past 27 years he provided counsel and advice to many students who needed guidance on entering the professions and the business world.

MOTION NO. 94-31: Trustee Gould moved, seconded by Trustee Sánchez, that in recognition of his distinguished service to Central Washington University, Mr. B. Dean Owens be granted Distinguished Administrator status, effective immediately.

Motion carried.

Distinguished Civil Service Status

Recommendations for the award of Distinguished Civil Service Status were received for the following staff members:

Darwin Davis, Instructional Media Center, who retired in September. Darwin began his career at his alma mater on September 12,1969 after graduating with a Bachelor of Arts degree, majoring in sculpture. The sculpture at the west entrance to the Language & Literature building is his work. Mr. Davis was greatly respected for his involvement with many areas of the university and was directly responsible for the graphic enhancement of University publications. Not only did he make a lasting visual impression on the university, he will be remembered by many for his lighthearted wit and his highly skilled, professional expertise in his field.

Britta Jo Hammond, Graduate Studies and Research, retired after 22 years of service to the university. Ms. Hammond was involved in every phase of the graduate program, and her assistance was highly valued by the students, the graduate council and faculty, and the administration. Well beyond the call of duty, Ms. Hammond also read through each thesis for every graduate student to make sure it was acceptable, a service seldom offered at any university. She was greatly appreciated and will be missed.

Harold McClure, Facilities Management, retired from his position of Custodial Lead on July 1, 1994 after serving CWU for almost 16 years. Throughout his career at Central, Harold was a dedicated, loyal employee, determined to perform with the highest standards. He is truly a credit to the custodial profession.

MOTION NO. 94-32: Trustee Gould moved, seconded by Trustee Sanchez, that in recognition of their dedicated service to Central Washington University, Darwin Davis, Britta Jo Hammond, and Harold McClure be immediately awarded Distinguished Civil Service status with all accompanying rights and privileges. Motion carried.

Report on Science Facility - Phase I - Schematic Design

Vice President Courtney Jones reviewed the project and said that it is still subject to change. It will be accomplished in two phases. We are presently funded for phase I.

The following discussion centered on the location and siting of the facility, and the parking implications if it is constructed on what is considered by the administration to be the best site. Also talked about was the external appearance, roof style (flat or gabled), and other aesthetic questions. Venting requirements dictate stacks on the building which would extend about 15 feet from the roof. One of the challenges will be to try to camouflage them. Phase 1 will encompass approximately 141,000 square feet at an estimated cost of \$31,493,270. The design team also tried to address the issue of flexibility to accommodate future requirements within the science programs.

As presently planned, the project will be ready to go to bid in September, 1995 with bid award anticipated by the first of April, 1996, followed by a 24-month construction period. It is estimated the building would be operable by September, 1998. Responding to Trustee Woods' question as to the kinds of problems as yet unresolved, President Nelson and Vice President Jones said they would say parking and the location of the power line as the major issues to be addressed.

BUSINESS AND FINANCIAL REPORTS AND RECOMMENDATIONS

Cashability of Retirement Benefits (TIAA/CREF participants)

The CWU Retirement and Insurance Committee recommended that the Board of Trustees amend its institutional retirement plan for Central's faculty and other eligible employees under the provisions of RCW 28B.10.400, allowing, at retirement or termination, rules permitting cash withdrawal of 100% of accumulations attributable to both the employee and employer contributions (subject to TIAA/CREF restrictions).

President Nelson told the board he would like to be on the record that, from a personal standpoint, he would not recommend this action, but that If the Board does decide to authorize 100% withdrawal, please state that Cenral Washington University will accept no financial planning responsibility if the person removes his/her money from the fund. We cannot have the university assume a position of liability in financial planning for individuals. While withdrawal would give the participant some flexibility, there are large tax implications to be considered. Discussion ensued.

Motion No. 94-33: Trustee Woods moved, seconded by Trustee Sanchez, that the Central Washington University retirement rules and regulations for faculty and administrative exempt employees be amended to permit, at retirement or termination, cash withdrawal of the dollars attributable to both the employee's and the employer's contributions, provided that they are in an annuity investment that can be cashed out

under TIAA/CREF rules. Further, that it be understood that the university will not assume responsibility for financial planning for individuals, nor will it accept any liability associated with withdrawal of funds by individuals. Motion carried. (Amendment will be published in the University Policies Manual, Part 2-2.18 Faculty and Civil Service Exempt Retirement Rules and Regulations.)

Briefing on Campus Master Parking Plan

Vice President Jones briefed the Board on some of the issues. Between now and the December Board meeting, a President's Advisory Council meeting will be held to discuss the issues with the campus and local communities. He anticipated it will come back to the Board in December for further consideration/action. As part of the Science project, we need to revisit the parking problems. Mr. Jones said that we do not have a shortage of parking on campus, but the location presents certain difficulties. He then gave an overview of assumptions, discussion points, parking lot location alternatives, and possible expansion points.

The meeting will be widely advertised so that all who wish to speak to the parking issue will have the notice and the opportunity.

Approval of the 1995/97 Capital Budget

The Administration presented to the Board a preliminary capital budget in June, and the proposed final budget was sent to the Trustees in September. Few changes were made. Our total request is for \$121,000,000. Our #1 priority is the remodel and addition-Black Hall.

Other elements of the proposed budget were discussed. Greg Carlson, President of the Board of Directors of the Associated Students of Central Washington University, asked to give a statement for the record. The Board chair agreed. Mr. Carlson stated: We, the Associated Students of Central Washington University, are opposed to keeping the president's house in the 95-97 budget. In the fiscal crisis and 601 environment, we believe it is not prudent to spend money on the remodel of a residence. The students believe we should set an example of prudence and frugality.

MOTION NO. 94-34: Trustee Sánchez moved, seconded by Trustee Gould, that the Board approve the 1995/97 Capital Budget as submitted. Motion carried with Trustee Curreri voting nay.

Approval of the 1995/97 Operating Budget

The proposed 1995/97 operating budget was presented in the amount of \$104,295,000. The budgetary details were reviewed. We have asked for increased enrollment to help accommodate the anticipated increase in requests from the populace to gain access to higher education. We cannot continue to take students above the enrollment funded without endangering the quality of our services.

Discussion ensued. President Nelson said that if we get no relief, we will have to consider holding the line on enrollment-which is contrary to everything he believes in. We have been forced to reexamine our position - rethink providing access.

Mr. Jones reported that the Legislature has said we should plan for a 2.4% cut. To provide for that eventuality, we pulled from the base \$800,000 per year. We hope our budget will not be cut, but we have planned for it.

Additionally we have been told to show planning for up to a 10% cut. If we really have to

address these issues, the loss could potentially be 25 faculty, 26 staff, and 500 students per year.

Mr. Jones said that we have met the requirements of the Office of Financial Management in terms of all our budget submissions. Regarding the 10% cut, we have not had a reaction yet. We were asked to submit our plan in a different format than in the past. It takes more involvement and lead time to avoid the deleterious effect of targeting people and lowering morals. We believe we have done that.

MOTION NO. 94-35: Trustee Woods moved, seconded by Trustee Curreri, that the Board of Trustees approve the 1995/97 Operating Budget request in the amount of \$104,000,000 as submitted. Motion carried.

OTHER REPORTS AND RECOMMENDATIONS

Provost/Vice President for Academic Affairs

Provost Moore reported on the award of a grant, spearheaded by Professor Kenneth Hammond of the Geography Department, which is specifically provided to train native Americans in the area of resource management. This grant indicates the commitment of the institution to provide this kind of education so the participants can go back and share their expertise with others. We will take between 5 and 8 students a year. It will cover approximately a four-year span and is subject to renewal. The amount of \$350,000 will be given the first year with participants from Oregon, Idaho, Alaska, and Washington.

The Northwest Association of Schools and Colleges recently finished our interim (5-year) visit. The visit was very successful and we believe we will get a very favorable report. The Provost will report back when our letter is received.

The Provost also reported the status of special accreditations, Summer Session, and the results of faculty hires.

Vice President for Student Affairs

Vice President Trujillo focused his report on the financial aid element of his division and stated that it is a very important factor in the life of many students. Over the years numerous changes have occurred.

Dr. Trujillo then introduced Ms. Donna Croft, Director of Financial Aid, who gave a detailed report and presentation. More than 50% of the students at Central Washington University receive financial aid. Increased demand is occurring statewide.

Discussion ensued.

Chair Dotzauer thanked Ms. Croft for her comprehensive, excellent report and expressed his appreciation of her work and that of her staff in serving the needs of the students.

Vice President for University Advancement

Vice President Young reported that Martha Lindley has been hired as the Director of Government and Corporate Relations. Ms. Lindley will come to campus for orientation and will then be housed in our SeaTac Center. She will work with all constituencies of the university.

Mr. Young also reported that the CWU Foundation has received \$62,000 from the Petrie Trust to purchase computer equipment, and that the "Central Today" newsletter has shifted focus from being an Alumni newsletter to reach a broader constituency. The publication costs 72 cents per copy to produce and mail.

Faculty Senate

Faculty Senate Chair Sidney Nesselroad reported that the Senate had its first meeting this week. Frank Carlson was appointed to be the Senate Legislative Officer this year.

The Senate was apprised of the possible 10% budget cut alluded to by the President, and the Senate budget and legislative representatives submitted a letter helping to establish the priorities. Also, the Senate was involved in the accreditation visit by the Northwest Association of Schools and Colleges.

Members of the Senate have prepared a response to the ethics bill recently passed, attempting to make sure some internal policies are in place to protect faculty.

Board of Directors, Associated Students of Central Washington University (BOD, ASCWU)

Greg Carlson, President of the BOD, ASCWU, reported that the students have been working hard since the beginning of the year, and are excited about their progress on projects such as the Big Buddies (linking university students, youth, and community organizations together); support for a Volunteer Center; and BOO Central where they will host over 500 children for a fun and safe Halloween in the SUB.

Mr. Carlson also reported that: the Student Handbook is almost in final form; the BOD will be sponsoring political forums in the SUB; and the ASCWU support the idea of a Taco Bell in the Student Union Building, but oppose keeping the presidential house in the 95-97 capital budget.

Association of Exempt Administrative and Professional Employees

Association President Wayne Barnet said that the first formal meeting has not yet been held. A report will be given in December.

PRESIDENT'S REPORT AND RECOMMENDATIONS

Report on Food Service Planning

President Nelson reported that Mr. Rich Corona, Business Manager and Chair of the Commercial Activities Committee, and the Chamber of Commerce Small Business Committee have been working together on this issue. We have certain responsibilities to the students, but we are also involved in the community concerns. The Chamber of Commerce has done a survey of their membership relating to the subject which will be thoroughly examined. The options, mutual cooperation, acceptable solutions, etc. will then be discussed. Mr. Corona said he was very pleased with the way the meetings have gone. It is an ongoing process, but the hope is to continue to exchange information which will be brought back to Cabinet and President Nelson. Mr. Corona was also going on a public radio show to discuss the issues.

Report on Foundation Relations

The foundation is going through a period of reorganization. Things are going forward in a positive way.

Strategic Planning

The Board had received a copy of the draft document which will soon be updated.

Report on Budget Cut Planning

President Nelson handed copies of the official OFM letter to the Board along with copies of the letter from the Faculty Senate in which they acknowledged their involvement in the planning process indicated their concerns. He thanked the Senate and all who supported this effort and said he was pleased to receive feedback indicating that they understood and supported the administration's position, but if the 10% budget reduction happens, it will hurt the institution.

Trip to Japan

President Nelson explained the need for him to travel to Japan to reaffirm the university's ties with those institutions with which we have working agreements and/or sister-university relationships. We presently do \$1.5 million in business with the Japanese schools. It will take 21 days to complete the circle and cover all the pertinent locations. Funding for the trip will come entirely from self-support funds generated by contract programs with our Japanese partner institutions through Central's Office of International Programs.

MOTION NO. 94-36: Trustee Woods moved, seconded by Trustees Sanchez and Gould, that the Board of Trustees approve the President's trip to Japan from October 15 through November 6, 1994, as described. Motion carried.

BOARD OF TRUSTEES

Gloria J. Craig, submitted her resignation as Secretary to the Board of Trustees, effective upon her retirement, December 31, 1994.

Chair Dotzauer stated that Ms. Craig has been very important to the board. President Nelson added that she has been a joy and a pleasure to work with, and an excellent partner to him. She will be missed.

MOTION NO. 94-37: Trustee Gould moved (reluctantly) to accept the resignation of Gloria J. Craig as Secretary to the Board of Trustees effective December 31, 1994. Trustee Woods seconded (reluctantly) and the motion carried.

Board of Trustees committee structure

The Board briefly discussed its committee structure, but deferred decisions to a later meeting.

COMMUNICATIONS

The Board acknowledged receipt of the September 12, 1994 letter from Jennifer M. Belcher, Commissioner of Public Lands.

NEXT MEETING

The next regular meeting of the Board of Trustees is scheduled for December 2, 1994, in Room 412

of Barge Hall on the Central Washington University campus beginning at 11:00 a.m.

Provost Moore referred to the first annual Fall Convocation to be held in the evening and thanked the Board for participating. Dr. Beverly Heckart will deliver the main address.

Chair Dotzauer also announced the Trustees would participate in the dedication of the new regional archives building at 2:30 p.m.
