State Auditor Report: Central Washington University

Corrective action has been taken on the three items identified in the audit report.

1995-96 Operating Budget

Higher education reductions approved during the recently completed legislative session were reviewed. Strategic planning drives the budget for Central Washington University. Accordingly, the university cut its base budgets during deliberations last year and established budget reserves which made this year's legislative actions less painful. As specified by Initiative 601, the budget is now controlled by year rather than biennium. This year's budget will be tight with the possibility of greater flexibility next year. Financial aid and tuition increases were mandated for the biennium; however, access must be increased to accommodate additional enrollment.

1995-96 Tuition and Fees

Recent tuition changes were discussed and legislative intent reviewed. Institutions are required to accelerate degree completion time and report on measures taken to achieve degree completion goals. Faculty contact hours must also be increased.

1995-97 Services and Activities Biennial Budget (S&A)

Presented to the Board with unanimous approval of the Services and Activities Committee.

Faculty Salary Adjustment

Faculty will receive a 4 percent salary increase each year of the biennium.

Administrative, Civil Service Exempt Salary Adjustment

Salary increases for administrative, civil service exempt employees include increases of 3.5 percent across the board and .05 percent apportioned to elevate salaries which fall below College and University Personnel Association (CUPA) minimums. Last April the university adopted the CUPA method of comparing administrative salaries.

The legislature failed to fund the total cost of faculty and administrative, civil service exempt salary increases. That short funding and other anticipated increases must be included in budget planning.

1995-97 Capital Budget

Details of the university's strong capital budget for 1995-97 were discussed including commitment to the new Science Facility, Hertz Remodel, movement of Naneum Modular, computing infrastructure, Lind Hall Remodel, expansion of WHETS linkages, and renovation of Black Hall.

Provost/Vice President for Academic Affairs

Provost Moore reported that persistent leadership has resulted in increased computer access for faculty and students. He briefed the Board on reorganizational changes to the College of Letters, Arts, and Sciences and the College of Professional Studies and praised the deans and faculty for their successful efforts. Many new faculty members will be hired this year affording new challenges and opportunities. A new master's program in Geology was recently approved by the Higher Education Coordinating Board (HECB). A Master in Music Business program will be presented to the HECB in July. Dr. Gerry Stacy will be leaving his position as Dean of Graduate Studies and Research to return to teaching fail quarter. Dr. Stacy has served with distinction, worked well with faculty, and increased graduate enrollment and grant activity.

University Advancement

Vice President Young praised Gail Jones for her service as Central's Alumni Director for the past 18 years. Chair Dotzauer echoed Mr. Young's commendation and said that Mrs. Jones was a tremendous ambassador for the university.

<u>Community Development Plan</u> - The leadership of Ron Dotzauer and Jim Norman in the development of this group was acknowledged. Mr. Dotzauer thanked Mr. Norman, community members, and Jen Gray for their dedication to the concept of mutual collaboration and growth. Membership composition was discussed.

Distinguished Alumna - Marilyn Grey, a Central alumna, will be this year's commencement speaker.

<u>Development Report</u> - Development support is an investment that produces rewards. Giving in all areas has increased. Additional scholarships will be offered through the Central Investment Fund. Sale of the Rothlisberger property will provide the CWU Foundation with \$145,000.

Lagislative Session Overview - Martha Lindley, Director of Governmental and Corporate Relations, discussed several legislative issues from the 1995 session including enrollment, budget, carry forward provisions, access, time to degree, faculty productivity, and remedial education. Legislators will be working during the interim on many issues including a statewide university system with a single governing board, commercial activities, and alcohol on campus. Trustees were encouraged to consider issue positions for next year. The Governor's task force on higher education will examine funding and other issues. President Nelson was commended for his leadership of the Council of Presidents (COP) this year. For the first time, the COP prepared a unified policy agenda. The Legislature has recognized the successful cooperative effort demonstrated by Central's twoplus-two program with the community colleges. Chair Dotzauer thanked Ms. Lindley for her fine representation of the university.

Faculty Senate

Faculty Senate Chair Sidney Nesselroad indicated that the faculty appreciated working with the Board this past year. Dr. Hugh Spall, Economics, will serve as Faculty Senate chair next year. The Faculty Senate continues to be interested in being part of a unified effort before the Legislature. Mr. Dotzauer thanked Dr. Nesselroad for capably representing the Faculty Senate.

Board of Directors, Associated Students of Central Washington University

Current president, Greg Carlson, introduced Brian Dolman who will serve as the ASCWU president for 1995-96. The student/community issue of providing a Taco Bell franchise in the Samuelson Union Building was reviewed. Members of the Chamber of Commerce and student government are continuing discussions. President Nelson commended student leadership for their mature, professional behavior. Mr. Dotzauer concurred. Other recent student accomplishments discussed included an ombudsman survey, resumption of broadcasting for radio station KCAT, funding of a student alumni group, and establishment of a mentor program for freshmen.

Association of Exempt Administrative and Professional Staff

Wayne Barnett, chair of the Association of Exempt Administrative and Professional Staff, introduced Lisa Garcia-Hansen as the association's president for 1995-96. He indicated association support for the salary increase proposed for administrative exempt staff and encouraged the President to consider merit provisions to reward excellence. Chair Dotzauer thanked Mr. Barnett for his efforts this past year.

PRESIDENT'S REPORT

<u>Strengthening public perception of higher education</u> - President Nelson shared an idea designed to strengthen public perception of higher education and requested that a member of the Board participate in a collaborative group.

<u>Report on Russia/Hungary trip</u> - The President's recent trip to Russia and Hungary was successful. Faculty and student exchange agreements were signed with Herzen in St. Petersburg and Jannus Pannonius in Pecs, Hungary. President Nelson stressed that such agreements provide excellent opportunities for our students and faculty.

<u>Trust Lands</u> - The Commisioner of Public Lands' habitat conservation program could create a potential revenue decrease for higher education institutions. President Nelson wanted the Board to be aware of the situation.

RESOLUTION NO. 95-04

Equal Opportunity and Affirmative Action at Central Washington University

Whereas, Central Washington University Board of Trustees and administration have established programs, processes and procedures to foster their commitment to affirmative action and gender equity in educational programs and athletics, and

Whereas, Central Washington University recognizes the importance and necessity of reflecting the cultural diversity of the citizens of the state of Washington in its student body, faculty, staff and administration, and

Whereas, Central Washington University believes the richness of its educational experience is supported by its commitment to affirmative action and gender equity in educational programs and athletics,

BE IT THEREFORE RESOLVED, that the Board of Trustees reaffirms and publicly states its continued commitment to affirmative action and gender equity in educational programs and athletics at Central Washington University.

BE IT FURTHER RESOLVED, that the Board of Trustees of Central Washington University requests that its administration, faculty, and staff maintain their programs, processes, and procedures for continued implementation of affirmative action and gender equity in educational programs and athletics.
