University Advancement

President Brian Dolman reviewed student legislative activity, an ASCWU resolution supporting food options in the Samuelson Union Building, student identification numbers, technology fees, championship football game support, and student involvement in clubs and organizations. President Nelson commended Mr. Dolman for his leadership in encouraging student legislative involvement.

# Association of Exempt Administrative and Professional Staff - no report

## PRESIDENT'S REPORT

President Nelson presented the following five items for Board review: Central's 1996 Supplemental Budget Request, Washington Higher Education Network (WHEN), Maximum Student Capacity in Instructional Facilities, Ethics Legislation--University of Washington Proposal, and the Council of Presidents' 1996 Legislative Agenda Guiding Principles.

The Higher Education Coordinating Board (HECB) has removed its service area concept. The contributions of Central's off-campus educational centers are being recognized. We have been colocating on community college campuses and providing a more cost-efficient solution to access problems.

Distance learning serves placebound students and provides interactive student/faculty contact. Central would be part of a statewide distance learning network and receive additional voice and digital capacity through the WHEN project. A demonstration of our distance learning program will be arranged for the Board next quarter.

# BOARD OF TRUSTEES REPORTS AND RECOMMENDATIONS

Mr. Glover requested a briefing on the Science Facility Phase I and the Black Hall Renovation. Planning funds included in our supplemental budget request will allow architects to continue the design for Phase II of the Science Facility Project.

Ms. Chaplin inquired about the Department of Natural Resources' Trust Beneficiaries Group. The group was established by DNR to improve communication with trust beneficiaries.

Resolution Affirming Continued Use of Internal Auditing at Central Washington University
Vice Chair Chaplin read a resolution affirming the continued use of internal auditing at Central
Washington University (Resolution 95-09). Text of the resolution follows:

Central Washington University Board of Trustees Resolution 95-09

WHEREAS, the Central Washington University Board of Trustees is committed to performing its stewardship role by assuring quality of academic performance, achieving economical and efficient use of resources, protecting university assets, and ensuring compliance with state and federal rules and regulations, and

WHEREAS, the Board of Trustees is accountable for the adequacy and effectiveness of the university's systems of internal control, and

WHEREAS, the Board of Trustees values the use of internal auditing as an integral management tool, to improve the operations of the university, and to ensure that all academic and administrative sectors of the university operate in compliance with state and federal laws and regulations, and

WHEREAS, by program review — which measures and evaluates the reliability and integrity of data in all university systems; the economy, efficiency and effectiveness of administrative and academic operations; and the effectiveness of various types of controls — internal auditing at CWU serves to ensure the accomplishment of established objectives and goals for all university programs-academic affairs, student affairs, business and financial affairs, advancement, and executive; isolate problem areas and provide a means of corrective action before operational efficiency is affected; provide internal checks and controls for effective management; improve communication channels within the university; provide counsel and advice to management regarding compliance and regulation issues, and

WHEREAS, Washington State taxpayers, businesses, lawmakers, public media, bondholders, and private citizens are interested in university's management of their tax dollars.

NOW THEREFORE BE IT RESOLVED, that this Board of Trustees commends President Ivory V. Nelson for his judicious, appropriate, and continuing use of internal auditing—to ensure academic and administrative excellence at Central Washington University, and to preserve and protect the university's image and reputation among all its stakeholders.

ADOPTED this eighth day of December, 1995

Responding to questions concerning the auditing function, Ezzat Mina, Director of Auditing and Control, explained institutional auditing priorities and his independent operation. State audit reports have been excellent.

Motion No. 95-45: Trustee Sells moved, seconded by Trustee Woodhouse, that the Board of Trustees approve Resolution 95-09 affirming continued use of internal auditing. Motion carried.

Support for University/Community Relationships

Vice Chair Chaplin congratulated the Associated Students of Central Washington University and the Ellensburg Chamber of Commerce for engaging in good-faith negotiations regarding the Mexican-style food kiosk issue. Both groups have worked hard to justify their respective positions and positive communication between the university and the Ellensburg community has developed as a result. We hope this constructive process will continue.

The Board of Trustees supports student efforts to go forward with this bid.

#### Resolution Affirming the Board of Trustees' Commitment to Open Communication Text of the proposed resolution follows:

Central Washington University Board of Trustees Resolution No. 95-10

WHEREAS, the Central Washington University Board of Trustees is committed to governing the university to the best of its ability, and

WHEREAS, the Board of Trustees recognizes that the university's students, faculty and staff are vital constituents of the institution, whose close association with Central Washington University gives them the opportunity to assess the programs in which they participate daily, and

WHEREAS, the Board of Trustees perceives that open communication with the university's students, faculty and staff is an integral part of effective governance,

NOW THEREFORE BE IT RESOLVED, that the Board of Trustees will endeavor to build into its annual schedule occasions in which CWU board members, students, faculty, and staff can become acquainted as well as share ideas, listen to concerns, and solicit feedback on matters of interest to the Board.
