#### MINUTES REGULAR MEETING BOARD OF TRUSTEES CENTRAL WASHINGTON UNIVERSITY April 19, 1996 11:00 a.m.

The regular meeting of the Board of Trustees of Central Washington University was called to order by Chair Ron Dotzauer at 11:05 a.m., April 19, 1996, in Room 305 of the Sno-King Building at the Central Washington University Lynnwood Center on the campus of Edmonds Community College.

Mr. Dotzauer welcomed everyone to the meeting and expressed appreciation to Edmonds Community College President Jack Oharah for supporting the excellent cooperative relationship enjoyed by our institutions.

#### CHANGES TO THE AGENDA

The following additions or changes to the agenda were accepted: Item 1, minutes of the Special Meeting held April 12, 1996; Item 15, tenure-track faculty appointments for 1996-97 for Richard E. Negron, Assistant Professor, History and Kalala J. Ngalamulume, Assistant Professor, History; Item 15, amended back-up material for Bang-Soon Yoon, Political Science; Item 17, spelling correction for Captain William R. Kalms; and Item 30a, CWU State Audit Report from July 1, 1994 through June 30, 1995.

#### APPROVAL OF MINUTES

Motion 96-08: Trustee Woods moved, seconded by Trustee Glover, that minutes of the special board meeting of April 12, 1996, special board meeting of March 7, 1996, regular board meeting of February 2, 1996, and special board meeting of February 1, 1996, be approved. Motion carried.

Motion 96-09: Trustee Chaplin moved, seconded by Trustee Woods, that in order to facilitate the timely construction of the new science building and to use our resources and energy to focus on Central Washington University's mission to educate students and facilitate learning rather than focusing on litigation and conflict, the Board of Trustees authorize President Nelson to negotiate an alternative route for the Puget Power lines--a route that jogs around the new science building.

Implicit in this motion is my trust that CWU, Puget Power, and the Ellensburg Community will seek a long-term solution that will remove the power lines from the city limits of Ellensburg.

Dr. Nelson stated that presently incurred and projected costs for relocation of the power lines could equal \$1.226 million and that funds for an alternate route would be taken from the equipment line item of the new science facility appropriation.

Dr. Woodhouse made the following statement in support of the first paragraph of the motion: "My responsibility as a trustee of this institution is to serve the interests of all the citizens of this state to the best of my ability. In so doing, I am ever mindful that the essential essence and *raison d'être* of the university is to provide a quality education to students. So, it is with that in mind, that I cast my vote today for the decision which hopefully will avoid further costly delays and will ultimately result in the maximum possible amount of dollars devoted to instructional purposes."

It was proposed that the motion language be amended to "... authorize President Nelson to negotiate a temporary alternative route..." Motion did not receive a second and failed.

By a show of hands, Motion 96-09 received six affirmative votes and one negative vote. Motion carried.

Motion 96-10: Trustee Glover moved, seconded by Trustee Chaplin, that the Board of Trustees of Central Washington University provide leadership in establishing a work group that will research, evaluate, and recommend an alternate route, outside the CWU campus and City of Ellensburg, for Puget Power's 230,000 kv transmission line. Membership on the work group will include representation from Central Washington University, CWU Board of Trustees, the City of Ellensburg, Citizens for a Beautiful Community, and Kittitas County.

Motion 96-11: Trustee Sells moved, seconded by Trustee Woodhouse, that Motion 96-10 be amended to "... The Board of Trustees of Central Washington University ((provide leadership)) work in partnership with the community in establishing a work group ..."

By a show of hands, Motion 96-10 and its amending motion, Motion 96-11, received six affirmative votes and one negative vote. Motions carried.

Motion 96-12: Trustee Glover moved, seconded by Trustee Chaplin, that the CWU Facilities Management staff, in conjunction with Puget Power, develop well-defined cost estimates for (a) the above-ground route between Dean Hall and the new science facility following the route selected for a temporary "shoo-fly," (b) the above-ground route going east along the irrigation canal and south on Walnut Mall back to the existing line within the old railroad corridor, and (c) a buried 230,000 kv power line following the most efficient, least costly route around the new science building using appropriate, cost-effective low-EMF technology. By a show of hands, Motion 96-12 received one affirmative vote and six negative votes. Motion failed.

President Nelson assured the Board that all possible options will be explored and the Board will be briefed before any decision is made.

#### Auxiliary Services Room and Board Rates

Rob Chrisler, Director of Auxiliary Services, reviewed the 1995-96 Housing and Dining Services, Parking, Bookstore, and Productions/Central Services operations final figures and examined projections for next year. Private housing competition has impacted our housing occupancy somewhat. A small increase in room and board fees is proposed but family housing is unaffected. Special rates for continuing students and other incentives encourage students to live in university housing. Efforts to increase
