1991 Presidential Search

The Board invited individuals who participated in the 1991 presidential search to share their perspectives about the search.

Barbara Radke, media relations for the university during the search

A sense of secrecy surrounded the 1991 presidential search. People wanted to know what was happening which was reflected in media interest. Some things could not be shared as candidates' confidentiality had to be protected. Yet, the secrecy continued even when the new president was named. Ms. Radke suggested that an appropriate level of disclosure, including a well defined time line and predictable search activities, would help create greater support for the new president.

Jim Pappas, current Vice President for Enrollment Management and Marketing and interim president

The number of trustees on the committee and changing the job description after the search began were two process problems that occurred during the search. Applicant confidentiality was well protected. Dr. Pappas suggested that the search committee could define a list of criteria and ask applicants to write letters articulating their views. A brief institutional profile would accompany the list of criteria. Screening committee members should understand how to interpret credentials. All university community constituencies should be represented on the committee.

Anne Denman, professor of Anthropology and 1991 search committee member

Central Washington University has been strengthened over the last ten years; Ivory Nelson was one of the contributing factors. Dr. Denman listed four conclusions regarding the search process.

- 1. Greater openness and trust throughout the search process
- 2. Committee members should be accessible and prepared to contribute a great deal of their time
- 3. The outside consultant was not useful to committee members
- 4. Committee members should visit candidates' campuses

She emphasized faculty strengths and stated that faculty and students are the life blood of the university. Faculty have experience with academic and administrative hiring and are skilled at interpreting credentials.

David Gee, professor of Food Science and Nutrition and 1991 search committee member

Dr. Gee felt the Board of Trustees had their own agenda, separate from the search committee. Some faculty felt their feelings were disregarded. The committee chair refused to meet with faculty creating a hostile environment for the successful candidate. Committee members were rushed during the last stages of the search and were not given adequate time to analyze candidate information before unranked candidate names had to be forwarded to the Board. Dr. Gee felt the consultant was unable to contribute anything that would not have been done in any exempt search. It would be helpful if the Board's role on the committee was defined.

Agnes Canedo, Director of Financial Aid and coordinator of the 1991 search from October 1991 to conclusion

Ms. Canedo became connected with the search after the semifinalists were named. She indicated that the past eight years have been great for the university and reviewed several areas of improvement: facilities, strategic planning, administrative diversity, more open meeting agendas and minutes, and increased computing availability for members of the university community. Many good, experienced people served on the search committee. The consultant was instrumental in defining the job description and eligibility criteria. Ms. Canedo offered the following suggestions:

- 1. Address confidentiality issues by determining type of search from the beginning
- 2. Provide an adequate budget and detailed spending plan
- 3. Provide experienced support staff
- 4. Service on the committee is time consuming
- 5. Make public the Board's charge to the president
- 6. Establish a dynamic between the trustees, the new president, and the university community
- 7. More discussion before the final decision is made
- 8. Include a majority of faculty representation on the search committee

Jim Brown, professor and chair, Political Science

Dr. Brown supports faculty majority representation on the presidential search committee and stated that a majority of the faculty agree. Faculty representation should be elected by the faculty rather than appointed by the Board of Trustees.

Lisa Weyandt, associate professor, Psychology

Expressed hope that faculty and administration can have an amicable relationship throughout the search process.

Rich Corona, Associate Vice President for Business and Financial Affairs

Mr. Corona stated that there are many strong candidates for search committee membership among the ranks of classified and exempt employees. The search effort will be strengthened by inclusive participation.

Strategic Planning Committee

Mrs. Chaplin mentioned that three trustees (Chaplin, Glover, and Yu) attended a presidential search workshop at a recent Association of Governing Boards conference in Seattle. Participants discussed use of an outside consultant, setting a time line for the search, and establishing a clear set of rules governing the search. The search process and supporting budget will be defined and maintained throughout the entire process. A proposed time line for our presidential search was discussed: July 1999—leadership profile completed; Summer 1999—search committee established; February/March 2000—offer the position; April 1, 2000—Dr. Nelson retires. The Board asked the Strategic Planning Committee to help determine the leadership profile and duties of the new president using an inclusive process. Recognizing that a trust issue exists in the *Board of Trusteer* 2 April 16, 1999 university community, the Board will issue regular updates outlining decisions made and contemplated. Providing consistent information to all constituencies in a clear, concise manner will help foster trust. Individual communications will be acknowledged as they are received rather than waiting until the next Board meeting. This is the first presidential search experience for members of this Board of Trustees.

A preliminary process was discussed for securing input from the university community and developing a leadership profile and presidential daties. Suggested strategies include: involve groups who are currently meeting and encourage them to discuss issues—committee will gather information; ask 100 people to talk to 10 people in cross-unit conversations involving every constituency—synthesize information; utilize divisional meetings—vice presidents, deans, directors; and involve the trustees in campus discussions. We must determine whether we want to involve the greater community and state stakeholders in the effort, what information we need, and how it will be used. Responses will be analyzed and presented to the Board at their next meeting May 14, 1999. Strategic Planning Committee members value this important work and want to be involved.

Elements of a presidential position description must be measurable for appropriate evaluation. It was suggested that presidential duties be developed with a time frame for completion. Assessing our challenges and examining our priorities will help us identify desired candidate qualities, experiences, and critical skills. Development of the leadership profile is our first priority. Approved vision, mission, and goals are reaffirmed and will be discussed and revised after the leadership profile is developed. To facilitate completion of its tasks, the Strategic Planning Committee will be expanded. A communication strategy for the Board and the search process was discussed.

Action Items

Resolution Honoring Wilfred Woods

Mr. Wilfred Woods notified the Board of Trustees that he was resigning effective April 16, 1999. In recognition of his contributions to the Board, Mrs. Chaplin read Resolution 99-02 honoring Wilfred Woods.

WHEREAS Mr. Wilfred Woods was appointed to the Central Washington University Board of Trustees by Gov. Mike Lowry on March 12, 1993, reappointed by Gov. Lowry on October 3, 1995, and has served with distinction for the past six years, and

WHEREAS Mr. Woods has served as vice-chair of the Board during the 1996-98 academic years and again in 1999, as well as participating actively on the presidential evaluation committee and other Board committees, and

WHEREAS Mr. Woods has shared his vision of a many-campus system, and has committed his energies to assuring that the university extends its service and resources to place- and time-bound students seeking high-quality, affordable public education in other communities, not only in Ellensburg and at westside centers in Lynnwood,

SeaTac and Steilacoom, but also at reinvigorated eastern Washington sites in Wenatchee and Yakima, and at a new Moses Lake Center, and

WHEREAS Mr. Woods has brought to the CWU governing board his integrity and professional expertise, his ability to focus Board discussion on the realities of Central's mission and resources, and to articulate a complex discussion in understandable terms, as well as his sense of urgency about substantive issues the university faces, and

WHEREAS Mr. Woods has brought to the Board his vision that Central, as a regional university, should be a strong partner in each of the communities it serves, contributing to the cultural, educational and economic lives of citizens in those communities, and

WHEREAS Mr. Woods has contributed to Washington citizens' science literacy by exercising his wisdom, support and leadership for the Institute for Science and Society, and

WHEREAS Mr. Woods is a man who deeply cares about and supports the performing arts in his own community and at the university, not merely with his own financial contributions, but also by helping organizations form partnerships with other patrons,

NOW THEREFORE BE IT RESOLVED that this Board of Trustees wishes to publicly express appreciation to Mr. Wilfred R. Woods for his effective, intelligent and dedicated service as a member of the Central Washington University Board of Trustees from March 13, 1993 to April 16, 1999.

ADOPTED and signed this 16th day of April, 1999.

Motion 99-11: Mr. Reich moved, seconded by Ms. Yu, that Resolution 99-02 honoring Trustee Wilfred R. Woods be approved. Motion carried.

Mrs. Chaplin announced that Governor Locke has appointed Ken Martin, president and CEO of Cashmere Valley Bank, to succeed Mr. Woods.

Ms. Leslie Jones will serve as interim vice chair. Trustees Yu and Sells will serve on a nominating committee to present recommendations for 1999-2000 officers at the June 11 meeting. Ms. Yu, Mr. Glover, and Ms. Gillespie will serve on an orientation committee for Ken Martin and a new student trustee.

Financial Report, FY 1997-98

Motion 99-12: Mr. Glover moved, seconded by Ms. Jones, that the Financial Report of Central Washington University for the period July 1, 1997 through June 30, 1998 be accepted. Motion carried.

State Auditor's Reports, 1997-98

In each of the three reports, Central Washington University was found in compliance with state laws and regulations.

Motion 99-13: Mr. Reich moved, seconded by Mr. Glover, that the following state audit reports be accepted for July 1, 1997 through June 30, 1998: Central Washington University, Central Washington University Associated Students Fund, and Central Washington University Housing and food Services.

President Nelson's Retirement and Presidential Search Discussion

Motion 99-14: Mr. Woods moved, seconded by Mr. Reich, that Dr. Ivory V. Nelson's letter of intent to retire April 1, 2000 be accepted. Motion carried. [Ms. Gillespie did not vote.]

Mrs. Chaplin asked Senior Assistant Attorney General Teresa Kulik to explain the role of a student trustee. Ms. Kulik responded that the statute empowering student trustees prohibited them from voting in personnel matters. Recent information from the Education Division of the Attorney General's Office specifies that student trustees can participate in the process leading to the applicant phase of the search. At that point, which is deemed the beginning of the hiring process, the student trustee must withdraw from participation. The Board discussed information Mrs. Chaplin, Ms. Yu, and Mr. Glover received from a presidential search workshop at the Association of Governing Boards recent conference.

A proposed time line for the presidential search was discussed: July 1999—leadership profile completed; Summer 1999 search committee established; February/March 2000—offer the position; April 1, 2000—Dr. Nelson retires. Working backward from February/March 2000, we can begin to develop decision points. A small ad hoc committee of the Board--Jay Reich, Leslie Jones, and Gwen Chaplin—will outline the decision points for the time line.

Strategic Planning Committee Report

The Board of Trustees asked the Strategic Planning Committee to develop a process to gather input from the university community on values, mission, vision, goals, and presidential leadership. Phil Backlund, Chair of the Strategic Planning Committee, summarized his April 7, 1999 response to the Board request. Regarding use of the information gathered, Mrs. Chaplin suggested that the committee's preliminary work in developing a leadership profile would fulfill the role of an independent consultant. The Board is interested in an inclusive information-gathering process with the widest range of opinion. The presidential search process will be open and inclusive.

The committee was asked to focus on the leadership profile and consider revisions to the vision, mission, and goals at a later date. University priority issues should be considered in developing a measurable leadership profile. A preliminary process was discussed for securing input from the university community in the development of the leadership profile and presidential duties. The following methods were considered: involve groups who are currently meeting and encourage them to discuss issues; ask 100 people to talk to 10 other people in cross-unit conversations involving every constituency; utilize divisional meetings—vice presidents, deans, directors; and involve the trustees in campus discussions. A series of questions will be developed for participants with additional questions of choice encouraged. This is an opportunity for the university community to provide valuable input to the trustees and for the Board to listen and participate. The planning committee accepts its responsibility to foster inclusive dialogue and appreciates the Board's willingness to be involved.

A Board of Trustees will immediately implement a communications strategy to highlight actual or pending decisions to the greater university community. The resulting communication will be sent within a week of a Board meeting.

Motion 99-15: Mr. Glover moved, seconded by Mr. Reich, that the Board of Trustees immediately implement a communications strategy and distribute the resulting communication to the greater university community within a week of a Board meeting. Motion carried.

Future Action Items

Facilities Master Plan

Vice President Nasser thanked staff members who have worked with NBBJ consultants over the past three years to produce the university's draft master plan. Brian Hall, a representative of NBBJ, briefed the trustees and stressed the master plan's flexibility for campus growth, building space, infrastructure, parking, traffic impact, and other variables. Also discussed was joint recreation space with the City of Ellensburg, bicycle traffic paths, the John Wayne Trail, improved perimeter green space, and power lines. A final version of the plan will be presented to the Board in May or June 1999.

Fee and Rate Schedule/Proposed Fees

Proposed fee changes (academic fees, Alcohol Information School fee, placement file transmittal fee, and the Safe Ride fee) were reviewed and discussed. Underage drinking is a significant problem. The Alcohol Information School was developed with the City of Ellensburg to reduce costs to students using the program. Students voted overwhelmingly to endorse the Safe Ride program and accompanying fee. Bruce Eklund recommended that Safe Ride program funds be carefully monitored perhaps through an oversight committee.

Proposed Change in Eligibility Rules for CWU Retirement Plan

Part-time faculty who work more than 50 percent of full time for two or more consecutive quarters will be eligible for retirement benefits in perpetuity according to proposed changes to the CWU Faculty and Civil Service Exempt Retirement Rules and Regulations (CWU Policies Manual, Part 2-2.18). Administrators who work at least 50 percent of full time for more than six consecutive months would also be affected.

President's Report

Core Values Discussion/University Forum

Consistent with the Board's desire to define a set of values to drive university goals, members of the University Forum developed a set of core values during recent discussions which will provide a benchmark of prevailing attitudes. The

Strategic Planning Committee will be able to use these core values as they proceed with their task of involving the university community in meaningful dialogue about the vision, mission, goals, and leadership style. The Board thanked forum members for their efforts.

Operating/Capital Budget Request Update/1999-01

Detailed spreadsheets were provided which illustrated the progression of our operating and capital budget for 1999-01 through the legislative process.

Proposed Operating Budget, 1999-00

Three possible budget scenarios and planning priorities were presented. Anticipated revenues, tuition increase flexibility, and funding options for the academic support system were discussed. Each unit of the university has contributed money for the project over a five-year period.

Other Reports

Academic Affairs

Provost Daawalder indicated that faculty recommended for emeritus status on this agenda will be acknowledged at the May 14, 1999 meeting. In addition to his written report outlining details of noteworthy activities in each school and college, Dr. Daawalder discussed the Higher Education Coordinating Board master planning process. He noted the availability on the HECB web site of three master plan policy papers on enrollment, electronic learning, physical space capacity delivered by HECB staff to the board at its April 14 meeting. Dr. Roger Yu discussed the Symposium on Undergraduate Research and Creative Expression (SOURCE) which supports partnerships between students and faculty in creative research. Dr. Edmond Fischer, a 1992 Nobel Laurente in Physiology and Medicine, and Keith Lewis, Assistant Professor of Art, will keynote the symposium May 8.

Business and Financial Affairs

Mr. Nasser provided a Y2K readiness disclosure report. Potential computing malfunction problems associated with the Year 2000 are being monitored by the state of Washington. Relevant information technology (IT Y2K) and imbedded chip issues (Non-IT Y2K) were discussed. The purchase of backup generators and funding support were also reviewed.

Development and Alumni Relations

Mr. Young highlighted recent high school honors night events and a scholarship reception which recognized Central Washington University's donors and recipients of named scholarships and awards. Ron Sims, King County Executive, will speak at the university's westside commencement June 13, 1999.

Enrollment Management and Marketing

Dr. Pappas presented a written report on divisional marketing efforts and presented the university's Enrollment Management and Marketing Plan.

Legislative Report

Martha Lindley discussed two important pieces of legislation: SHB 1140, Financial Aid Policy, and SHB 1015, Tuition Waiver Bill. The policy bill for the State Need Grant program marks a shift in policy and funds needy students for the cost of tuition rather than the cost of attendance. The Tuition Waiver Bill will allow CWU to provide partial tuition waivers to students from WICHE states (the western states).

Short Break - group took a short break from 3:10 p.m. to 3:13 p.m.

Student Affairs - no report

Faculty Senate

Dr. Alsoszatai-Petheo expressed his appreciation for each Faculty Senate member's contribution over the past year. Senators will receive a letter of support for their service. Two possible scenarios for an adjusted Winter Quarter 2000 schedule necessitated by Y2K preparedness were discussed. The Faculty Code Committee will hold hearings to discuss changes to the Faculty Code before those changes are submitted to the Board.

Dr. Alsoszatai-Petheo presented a Faculty Senate motion encouraging the Board of Trustees to meet with the Concerned Faculty of Central Washington University to discuss the presidential search. Faculty demands reflect a concern that they be key players in the search process. Mrs. Chaplin indicated that the Board understood faculty concerns and an ad hoc committee will be addressing presidential search issues. The Board will not be meeting before the date mentioned in the

communication but accept the letter in good faith. Faculty are encouraged to participate in the Strategic Planning Committee initiatives.

Board of Directors, Associated Students of Central Washington University

Bruce Eklund introduced students present at the meeting, including those who are candidates for student trustee and ASCWU Board of Directors positions. He provided information on the SUB renovation project and complimented university staff and students who have worked to secure funding for the music education building.

Association of Exempt Administrative and Professional Staff

Margaret Smith presented information on exempt salary parity issues and corresponding budget issues. Approximately 29 percent of exempt staff fall below the 20th percentile of their CUPA position match. The CWU Administrative Exempt Salary Plan has set the 20th and 80th percentile on the CUPA table as recommended limits of the salary range.

Ms. Jones suggested that the Board recognize individuals for their accomplishments in a public way. We should reaffirm that our central mission is education, examine what is occurring in the classroom, and display talents. Identify what we do well as a team. The Board wants to share in those good things.
