## SPECIAL MEETING BOARD OF TRUSTEES CENTRAL WASHINGTON UNIVERSITY January 14, 2000

Dr. Norton announced that he would send each trustee a copy of the draft contract for Washington Federation of State Employees Bargaining Local 330. Union membership will have the opportunity to ratify the proposed contract January 25. A final contract could be presented to the Board for approval February 11.

Mrs. Chaplin reviewed the agenda and stated that the Board would discuss the process for receiving and reviewing input about the presidential finalists before convening an executive session to review information to be used to evaluate the finalists.

As vice chair of the Presidential Search Committee and at the request of Mrs. Chaplin, Jay Reich explained that visitation schedules and vitae information for the three finalists are available on Central's web page. The compact schedules provide varied opportunities for interaction with the candidates. Comments from observers and members of the search committee will be compiled by the search committee. Unranked information about each candidate will be presented to the Board during a joint session of the Presidential Search Committee and Board of Trustees February 10, 2000.
