SPECIAL/REGULAR MEETINGS BOARD OF TRUSTEES CENTRAL WASHINGTON UNIVERSITY February 11, 2000

Study Session

The study session began at 8:40 a.m. and recessed for lunch at 12:00 p.m. Trustees Gwen Chaplin, Nick French, Leslie Jones, Ken Martin, Jay Reich, Nadine Romero, Mike Sells, and Judy Yu were present as well as President James A. (Dolph) Norton, Provost David Dauwalder, Vice Presidents Abdul Nasser and Sarah Shumate, Roger and Deborah Fouts, Dean Richard Mack, Mark Leonard (KYVE), and Judy Miller.

CHCI Briefing - Dr. Roger Fouts presented an overview of the Chimpanzee and Hum an Communication Institute (CHCI) and its strong student-centered program. CHCI students are directly involved in interdisciplinary research in primate behavior and ecology, one of only three programs in the world. Subject-based research benefits both undergraduate and graduate students who are involved in laboratory management and animal care from a uniquely humane perspective. Chimposita provide educational outreach and recruiting tools and are open to the public. Enrollment trends, graduation rates, and the 2001-03 budget request for CHCI were also reviewed.

ETVE Discussion - A collaborative proposal between public television station KYVE and Central Washington University was discussed. CWU would provide studio and operational space for digital broadcasting while the station business office would remain in Yakima. Funding for capital equipment to support digital TV will be raised by KYVE through grants and solicitation. Mutual benefits and costs to the university were discussed.

Operating Budget Process – Dr. Norton reviewed details of a rearrangement exercise for the 2000-01 budget. Each unit is being asked to prepare a budget to meet its obligations with 90 percent of the current year's allocation. Implications of budgetary decisions must be identified. This exercise is designed to find money to increase the faculty salary pool and meet identified university priorities. A timeline for completion of the exercise was discussed. The Board is committed to the faculty and meeting institutional priorities. Dr. Dauwalder reviewed Summer Session budget details.

Restdence Hall Council - Residence halls have experienced several challenges this year including staff turnover, a greater advisor/student ratio, and alcohol issues. Dr. Shumate commended residence hall staff for their exemplary work.

Approval of Minutes

Motion 00-02: Mr. Reich moved, seconded by Mr. Sells, that minutes of the Regular and Special Meetings of December 10, 1999 and Special Meeting January 14, 2000 be approved. Minutes of the special meetings January 18, 24, and 31 will be submitted at the April 14, 2000 meeting. Motion carried.

Changes to the Agenda

The following changes to the agenda were accepted: Study Session - background information for CHCI briefing; Item 9, Legislative Briefing - backup; Item 10, Mission Statement - new draft; Item 18, Academic Affairs - additional backup; Item 26, Development and Alumni Relations - backup information.

Board Chair Report

Mrs. Chaplin recognized the special work of the Presidential Search Committee that exemplified the way we can all work together. The Board spent five hours with the Search Committee February 10 and heard a composite of many elements comprising search efforts. Trustees went into executive session to evaluate qualifications of the applicants and reconvened in open session at 10:50 p.m. authorizing Mrs. Chaplin to contact one of the candidates.

Motion 00-03: Mr. Reich moved, seconded by Mr. Sells, that the Board appoint Dr. Jerilyn S. McIntyre as president. Motion carried. (Mr. French abstained. Student trustees never vote on personnel matters.)

Members of the Board expressed excitement about Dr. McIntyre's appointment and look forward to working with her.

Nadine Romero and Ken Martin delivered brief reports on the activity of Board Academic Affairs and Students Affairs Committees respectively.

Discussion Items

Capital Budget for Nonacademic Buildings

At the request of the Board, Vice President Nasser presented nonacademic building priorities including the Super SUB and code issues in existing buildings. A Super SUB committee comprised of students and administrators will determine the type of facility to be built. The committee will present a recommendation to the Board April 14. Fire codes and seismic issues for residence halls and other buildings were also discussed.

Capital Budget Development - Academic Buildings

Vice President Nasser presented a preliminary 2001-03 capital budget request.

Summer Session Budget

Provost Dauwalder explained to the Board that the Summer Session 2000 budget reflects changes in process approved last year. Faculty salary increases, additional support for students at university centers, student work program initiatives, and less excess revenue to distribute to departments are some of the changes. The proposed budget increases tuition and reduces registration fees.

Motion 00-04: Mr. Martin moved, seconded by Mr. Reich, that Summer Session undergraduate tuition be increased to \$89 per student credit hour (SCH), postbaccalaureate tuition to \$99 per SCH, and graduate tuition to \$126 per SCH and registration fees lowered from \$50 to \$40 per student. Motion carried.

Operating Budget Preview

Mr. Nasser reviewed the study session discussion regarding the budget exercise for 2000-01. The Board affirm ed the process and acknowledged the anxiety it was producing. This is the beginning of a process of serious rationalization of our budget and reallocation is necessary. Resources are limited and we must be prepared to deal with budget limitations.

Dashboard Report – Academic Affairs

Mark Lundgren, Director of Institutional Studies, presented information regarding accountability measures and the learning outcomes assessment efforts required by the legislature.

Legislative Briefing

Director of Government Relations, Martha Lindley, presented a status report of the 2000 Legislative Session. Washington higher education institutions are working collaboratively toward their goals. A draft of a coordinated 2001-03 budget request and other coordinated issues were included in the status report.

Action Items

Mission Statement

Responding to a request from the Board of Trustees, Phil Backlund, Chair of the Strategic Planning Committee, reviewed the process by which the mission statement was reviewed and amended for presentation to the Board. The committee gathered information, developed a statement that was circulated to campus, and received input. Eight items were identified as essential elements and were placed in a narrative form. The resulting statement reinforces the uniqueness of the university and enumerates our shared values. The next step is to define a vision statement for the future.

Motion 00-05: Mr. Reich moved, seconded by Mr. Sells, that the revised mission statement be approved as submitted (copy attached). Motion carried

Program Review

Libby Street, Special Assistant to the President, reviewed the program review process and Board feedback that resulted in recommendations to address program review issues. Based on review by Dr. Norton, Provost Dauwalder, Vice President Young, Dr. Backlund, and Dr. Street, the following recommendations are proposed:

- Target six primary areas identified as weaknesses in the Northwest Association of Schools and Colleges (NASC) team evaluation report for clarification or improvement during the coming year
- Focus on an intensive program review during the remainder of the current academic year. Two areas were selected: Recruit and admit students and retain and advise students
- 3. Develop guidelines for use in the program review including a suggested role for the Board of Trustees
- Review the usefulness of the review process at the end of the year and decide if the process should be repeated in relation to the remaining functions.
- 5. Reinstitute program review of educational degree programs on a ten-year cycle
- Institute yearly reports as the primary mechanism through which data elements of interest to the Board and university faculty, staff, and administrators are updated routinely and reviewed.

Motion 00-06: Mr. Sells moved, seconded by Mr. Reich, that the proposed process to address program review issues be approved as submitted. Motion carried.

Faculty Code Interpretation

The Faculty Code Committee of the Faculty Senate recommended a code interpretation for Section 1.25 (CWU Policies Manual, Part 4-1.23) concerning the position of administrators, appointed to faculty positions, in the seniority rankings of departments that exist for purposes of reduction-in-force. The interpretation will be incorporated into the Faculty Code and submitted for Board approval this spring.

Motion 00-07: Mr. Reich moved, seconded by Mr. French, that for the purpose of administering Sections VI and XI of the Faculty Code, university administrators, originally appointed to their positions without faculty status but who subsequently are appointed to a tenure-track/tenured position with academic rank, shall begin to acquire seniority as of their appointment to faculty status. Unless otherwise specified in the appointment letter, the date of appointment to faculty status and the Board of Trustees' approval thereof shall serve as the contract dates for the faculty appointment. Motion carried.

Ratification of Bargaining Contract, WFSE Local 330

The new contract is for an initial term of three years from the date of signing, with automatic one-year renewal thereafter unless either party requests that it be reopened. The negotiators on both sides strongly feel this document provides a platform for improved relationships and better communication. Most significant is a new grievance procedure that encourages resolution at the lowest level. While maintaining all essential management rights, the contract also enumerates basic employee rights, particularly in the area of representation. Mr. Nasser expressed appreciation for everyone who worked on the contract.

Motion 00-08: Mr. Sells moved, seconded by Mr. Reich, that the Board of Trustees of Central Washington University accept and approve the proposed contract between Central Washington University and Washington Federation of State Employees (WFSE), Bargaining Unit #1. Motion carried.

Naming of the Psychology Research Facility

At Dr. Norton's request, a cross-divisional committee examined a request to name the building currently referred to as "Psychology Animal Research Facility" the "Chimpanzee and Human Communication Institution."

Motion 00-09: Mr. Reich moved, seconded by Mr. Martin, that the building now identified as the "Psychology Research Facility" be named the "Chimpanzee and Human Communication Institute." The Office of Facilities Planning and Construction is directed to produce renderings of all appropriate building signs and plaques and cost estimates to be available for review at the April 14, 2000 meeting of the Board of Trustees. Motion carried.

Endowment Spending Budget Fiscal Year 2001

The Endowment Spending Budget for FY 2000-01 was prepared in accordance with the CWU Foundation Budget Committee guidelines.

Motion 00-10: Mr. Reich moved, seconded by Mr. Sells, that the 2000-01 Endowment Spending Budget be approved as presented. Motion carried.

Tuition and Fee Waiver Budget Fiscal Year 2001

The recommended 2000-01 Tuition and Fee Waiver Budget Plan was prepared by the Tuition and Fee Waiver Committee. The budget is based on current tuition rates and 7600 FTE.

Motion 00-11: Ms. Jones moved, seconded by Mr. Reich, that the 2000-01 Tuition and Fee Waiver Budget be approved as presented. Motion carried.

President's Report

Many people contribute to the success of the institution. Dr. Norton congratulated the Board and the Presidential Search Committee for the selection of a new president. The bargaining contract with Local 330 WFSE is a milestone.

Other Reports

Academic Affairs

On the occasion of her phased retirement Spring 2000, Dr. Dauwalder honored Carolyn Schactler, Professor of Apparel Design, for her respected work over the past 26 years.

Jane Chinn, who serves as an instructional resource specialist in CWU's Center for Learning Technology, and Chris Smart, electronic media producer, have developed a distance-learning CD-ROM tutorial. The CD-ROM is being produced for use in preparing faculty who will be teaching courses through interactive television.

The university's accreditation status with the National Council for the Accreditation of Teacher Education (NCATE) was reviewed. Central Washington University's Center for Teaching and Learning—the unit directly responsible for CWU teacher preparation programs—received formal notice that its accreditation by NCATE, a national voluntary accrediting board, is confirmed for the next two years; however, the accreditation classification assigned to the CTL is "continuing accreditation with probation." NCATE measures our performance against standards. We met all twenty standards and 62 of the required indicators. We will notify students in the degree programs of our accreditation status and respond to possible questions. A committee of faculty and administrators who participate in delivery of education programs will develop a plan to address each of the seven concerns. Mr. Reich acknowledged that the findings are serious and we must take responsibility. We have a responsibility to the state to train new teachers and retrain established teachers. Full accreditation must be accomplished as soon as possible; probation is not acceptable.

Provost Dauwalder reported the following curricular approvals: Specializations in Tourism Management and Recreation Management for the BS in Leisure Services and the addition of a Theatre Arts Minor. A listing of programs submitted to the Higher Education Coordinating Board for preapproval status for 2000-01 was also presented.

Faculty Senate

Linda Beath, Chair of the Faculty Senate, distributed copies of the American Association of University Professors (AAUP) Redbook. The text of Dr. Norton's description of the 10 percent budget exercise delivered to the Faculty Senate is now available on the Faculty Senate web site.
