Central Washington University Board of Trustees Special/Regular Meetings April 12-13, 2001

April 12, 2001

Gwen and Don Chaplin hosted the trustees and President McIntyre for dinner Thursday evening. No action was taken.

April 13, 2001

Approval of Minutes

Motion 01-06: Mr. Reich moved, seconded by Mr. Sells that the board approve minutes of the regular and special board meetings of February 9, 2001. Motion carried.

Board Chair Report

Mrs. Chaplin reported that she attended an exit interview with the NCATE (National Council for the Accreditation of Teacher Education) review team April 11. Members of the team appreciated the warmth and helpfulness of those interviewed on the Ellensburg campus and at the university centers. Their preliminary report declared Central's Center for Teaching and Learning in "very good health." The center is comprised of

the university's teacher preparation, school psychology, school counseling, and school administration programs.

President's Report

Legislative Issues and Strategus

Linda Schactler, the university's interim legislative liaison, thanked the trustees and alumni for contacting legislators in support of Central's legislative priorities. Primary objectives include securing legislative funding for the music education facility and legislative approval of an enrollment stabilization and recovery process. Secondary objectives include securing legislative funding for competitive faculty salary increases and enhancing policymakers' perception of CWU. Our progress in these critical areas was reviewed. Dr. McIntyre thanked Ms. Schactler for her efforts.

Lipdate on Budget and Enrollment

Spring Quarter 2001 enrollment is 7,287 FTE. All university units are developing performance indicators to evaluate centrality, essentiality, quality, productivity, and the potential for outstanding performance. These elements will help us match the budget with the strategic planning process.

Synthesizing Committee Update

Libby Street, co-chair of the Strategic Planning Synthesizing Committee, reviewed the year-long process that culminated in a draft plan distributed to campus in March for public comment. Conversations with all campus constituencies have occurred and comments submitted. A summary document will be presented to the board in May.

Board Committees

Academic Affairs - Nadine Romero, Chair, and Jay Reich

Ms. Romero reported that Paul James, Professor of Biology, presented an overview of his interesting research with endangered salmon in the Yakima Valley. Various faculty members have shared their academic research with the committee. Dean Rebecca Bowers provided an overview of the NCATE review completed last week and the 20 standards examined. The NCATE process was well coordinated among the deans. Efforts to prepare for the NASC (National Association of Schools and Colleges) focused visit in the fall are proceeding on schedule. Accreditation efforts in the College of Business were also reviewed.

Resource Development - Judy Yu, Chair, and Mike Sells

The university will conduct a market survey of current and potential students as well as others who influence students' college choices. Dean Roy Savoian will present a summary of the progress of this survey in May. The survey, administered by STAMATS Communications, is scheduled to be completed June 1.

Action

Room and Board Rates 2001-02 and 2002-03

Increased room and board rates for a two-year period were proposed. Those affected by the increases participated in recent tenant group discussions. Programs and facility improvements funded from rent revenues were discussed and comparative market information was presented. The aggregate increase from all housing units for 2001-02 will fall within the limit of 4.5% over the rates for 2000-01, and by an additional aggregate average of 4.5% in 2002-03. While apartment rates are increasing from 6% to 8%, the standard shared room cost is rising only 3.7%, and returning students can actually decrease their cost because of meal plan incentives.

Motion 01-07: Ms. Yu moved, seconded by Ms. Jones that the room and board rates for 2001-02 be increased by an aggregate average of 4.5% over the rates for 2000-01, and by an additional aggregate average of 4.5% in 2002-03. Motion carried.

CWU/Edmonds Community College Higher Education Center

This project is to design and construct the Central Washington University/Edmonds Community College Higher Education Center on Edmonds Community College campus in Lynnwood,

Washington. This project has two phases. Phase I was construction of the primary facility parking lot (226 stalls) in an area of the campus where the old soccer field was located. The Phase II is construction of the new 48,859 square foot Higher Education Center building. The purpose of phasing the construction of the parking prior to the construction of the primary facility was to provide parking displaced from the primary building site and provide adequate access and space in and around the new building during the course of construction.

Motion 01-08: Ms. Yu moved, seconded by Mr. Sells that authority be delegated to the Vice President for Business and Financial Affairs or designee to award and execute a construction contract for the second phase of the overall project. Motion carried.

Endowment Spending Budget

The Endowment Spending Budget for FY 2001-02 was prepared in accordance with the CWU Foundation Budget Committee guidelines.

Motion 01-09: Ms. Yu moved, seconded by Mr. Martin that the 2001-02 Endowment Spending Budget be approved. Motion carried.

Discussion

Parking - discussion postponed vortil May 11

Tomlinson Stadium Major Repair

Tomlinson Stadium repair consists of three phases: removal and disposal of existing lead-based painted wood bleacher seating and foot planks and the supply and installation of new steel and aluminum bleacher seating and foot planks, removal and disposal of lead-contaminated soil, and major repairs to the exterior of the stadium structure, which includes the encapsulation of existing lead-based painted siding. All work should be completed by June 1, 2001.

Exempt Salary Plan

Proposed changes to the CWU Exempt Employee Salary Plan were reviewed. The Exempt Employee Association proposed the changes to strengthen the salary plan and provide greater consistency in the establishment of starting salaries. These changes do not affect salaries of current employees and have no impact on the budget.

Student Affairs - Ken Martin, Chair, Leslie Jones, and Shawnte Pearson

Discussion

Quality of Life Facilities Strategic Planning

Members of the Quality of Life Facilities Strategic Planning Steering Committee, chaired by Maren Oates, has been working with consultants since February to oversee the concept development and feasibility studies for all of the project facilities. The primary goal of this planning process is to identify and meet student needs outside the classroom by providing active Quality of Life environments on the Ellensburg campus. The Steering Committee is committed to overseeing a process that will bring significant areas of the university and Ellensburg community together in this important planning effort. A successful community dialogue has occurred.

Action

S&A Fee Supplemental Budget Allocations

The Services and Activities Fees Committee has approved supplemental allocations. These funds were approved in accordance with the procedure outlined in the Central Washington University General Guidelines and Procedures for Use of Services and Activities Fees.

Motion 01-19: Mr. Martin moved, seconded by Ms. Jones that the Services and Activities Fees Committee supplemental allocations for 2000-01 be approved as submitted. Motion carried.

Other Reports

Faculty Senate

Dr. Nelson reported that changes to the Faculty Code will come to the board in May. Improving faculty salaries is the major faculty legislative initiative.

ASCWU Board of Directors

Maren Oates reviewed recent activities or initiatives involving students including Club Madness, a project to renovate the train station, and a social security number bill before the legislature. It was suggested that we begin discussions with students regarding possible tuition increases. Students interested in ASCWU Board of Directors positions for next year must file by April 16. Primary elections are the end of April.

Staff Organizations - Kari Taylor, chair of the Employee Council, represented staff organizations. There was no report.
