#### Board of Trustees Minutes Special/Regular Meetings February 13-14, 2003

February 13, 2003

Board members met with Dr. McIntyre for dinner at the President's Reception Center. No action was taken.

February 14, 2003

Board Committee Meetings (8:00 a.m. to 1:00 p.m.) Trustees met with President McIntyre from 8:00 a.m. to 9:00 a.m. in Barge 410. Dr. McIntyre invited Margaret Smith to present a biannual report of the university's internal audit process. The Committee of the Whole met from 9:00 a.m. to 11:00 a.m., discussing several issues related to the SUB/REC project and a proposed summer session budget. Individual committees met from 11:00 a.m. to 12:00 p.m. to review various academic, fiscal, and student affairs issues. Dr. McIntyre and the board met again for lunch prior to the regular session at 1:00 p.m. No action was taken.

Introductions — Item 30 in the consent agenda is a recommendation to grant emeritus status to Professor Dorothy Purser, who passed away July 28, 2002. Ethan Bergman, Associate Dean of the College of Education and Professional Studies, reviewed Professor Purser's long and distinguished career. Contributions to the university included founding the paramedic program in 1973 and guiding it to its premier status in the state, as well as coaching women's basketball and field hockey. In addition, she coached a Yakima women's fast-pitch softball team and taught swimming, lifesaving and water safety, cardiopulmonary resuscitation (CPR), and aquacize classes.

#### Approval of Minutes - 1

Motion 03-01: Mr. Reich moved, seconded by Mr. Martin, that the Board of Trustees approve minutes of their meetings December 5-6, 2002. Motion carried.

#### Changes to the Agenda -2

The following changes were presented: Executive Session – addition of an executive session to consider selection of a site or the acquisition of real estate; Item 9, Curriculum Deletion – move to action; Item 14, John Wayne Trail Charter Agreement – move to action; Item 15, S&A Supplemental Allocations – additional allocation for the Equity and Services Council.

#### Board Chair Report - 3

Ms. Chaplin reported that Leslie Jones attended a meeting with Governor Locke and other trustees and presidents of public baccalaureate institutions February 13 to discuss options for future funding of higher education. Judy Yu and Jay Reich have each attended recent meetings on the same topic. Margaret Smith presented a biannual audit report and reviewed ethics training opportunities presented by her office. The board also attended a Career Services open house.

On behalf of the board, Ms. Chaplin complimented those involved in recent public processes in support of the SUB/REC project and applicated the insert published in the Daily Record as a helpful synthesis of several of the project's important issues. Mr. Reich suggested that the SUB/REC project is more than a building. It is a metaphor for a new management team and a new spirit of communication across communities. The whole decision-making process at the university has changed.

#### President's Report

Dr. McIntyre thanked the board and acknowledged key members of the project team charged with managing several complex issues – Rich Corona, Libby Street, Mark Anderson, and Linda Schactler.

#### Legizlative Preview -4

Budget issues are dominant at this point in the legislative session. Dr. McIntyre reported that she recently sent a memo to the university community describing the situation and outlining details of the university's budget request. Our operating budget priorities include restoration of funds previously cut and salary increases. We are urging legislators to rebase our budget in reponse to strong enrollment growth. The university's priority capital project is Phase II of the Music Education Facility. We have put funds into preservation projects wisely over the years resulting in a relatively low preservation need. Consequently, our legislative team is urging lawmakers to listen to the judgment of those managing the institution and support our new project priority. A few of our music students gave effective, articulate testimony in Olympia recently about the need for completing the facility.

Dr. McIntyre reviewed three proposed bills one would penalize students who take more credits than the minimum allowed for graduation, another would strengthen residency requirements, and a third would redirect program funding to high demand programs was reviewed. Other legislation would tighten the hiring freeze on state positions as a continuation of a prior directive from the governor. We have had control mechanisms in place for some time and have been managing this issue carefully.

The governing boards task force discussion suggests the Evans/Gardner initiative and is working on creating an increased awareness of the need for reformation of higher education funding.

#### Celebrating Special Accomplishments - 5

As part of her ongoing effort to highlight meritorious accomplishments, Dr. McIntyre celebrated the unveiling of Central's "new look." A small pool of enrollment recovery funds led to research and an integrated marketing plan. This exciting new plan spotlights the qualities we feel makes Central a strong university. She reviewed the

process and outlined results. University staff implemented the plan based on consultant input. Variations of letterhead and other materials presenting a unified and compeling visual image were displayed. Web presence is critical in telling students about Central. Based on consultant recommendations, the web site will be redesigned over the next year.

Web site content team member Dean Liahna Armstrong reviewed some content adjustments to the site. The goal is a system where the user can move efficiently to find information. Utilizing a template-based format, navigation within the redesigned site will be clear and logical. Another goal is fewer rather than more links on a page, starting with basics and descending deeper to specifics. Language will be simple, catching, and unconfusing; images will be sharp and clear. Five major categories for the site are: home, admissions, academic programs and support, alumni and friends, life at Central, and administration. All university units fit within these categories.

Additional temporary employees will be added to the web staff to build the new site. Computer Science students will be hired to provide ongoing maintenance of the redesigned site. Bret Bleggi and other members of the marketing team were complimented on the scientific yet creative approach to the web redesign.

#### **Board Committees**

#### Academic Affairs - Jay Reich, Chair, and Nadine Romero

Mr. Reich reviewed an impressive presentation about the library presented to members of the Academic Affairs Committee in the moming committee session. Central students will benefit from future database merges that will provide increased access to public and private institutions in the west. Libraries are reinventing themselves and strengthening their relevance. Professor Daniel Cann-Casciato shared a report from the salary administration board, a group charged with rewarding faculty compensation excellence through distribution of a small amount of funds. Also discussed was a Faculty Senate report on compression and equity, standing committees of the faculty, and elevating faculty to CUPA means.

Action Items

#### Program Approval [Masters of Education: Inclusive Teaching Strategies] - 6

Following approval by the Faculty Senate, the new Masters of Education: Inclusive Teaching Strategies was submitted for board approval.

Motion 03-02: Mr. Reich moved, seconded by Ms. Romero, that the Board of Trustees approve a new program, Masters of Education: Inclusive Teaching Strategies. Motion carried.

#### Distance Educaton Compensation - 7

Adjustments to the Distance Education Compensation policy will encourage and reward faculty for creating courses with distance education components. Proposed changes have been approved by the faculty and the provost and will provide a formula for faculty compensation and true recognition of the added burden of this type of teaching. Additional tuition is not assessed for distance education courses.

Motion 03-03: Mr. Reich moved, seconded by Ms. Yu, that the board approve the requested additional compensation for concurrent sections in the distance education environment as submitted, effective Winter Quarter, 2003. Motion carried.

#### Summer Session Budget 2003 - 8

Increases to the Summer Session 2003 tuition consistent with changes for the academic year were reviewed.

Motion 03-04: Mr. Reich moved, seconded by Mr. Sells, that the board adopt the Summer Session 2003 budget, effective Summer Quarter, 2003. Undergraduate tuition will be increased to \$105 per credit (\$98 in 2002), graduate tuition to \$153 per credit (\$135 in 2002), and \$130 per credit for post-baccalaureate students (\$115 in 2002). Motion carried.

Curriculum Changes [New Specializations, Minors, Certificates] - 9

A recommendation to delete a program in Operations Managaement and Information Systems was presented.

Motion 03-05: Mr. Reich moved, seconded by Ms. Yu, that the board approve deletion of the Operations Management and Information Systems Specialization. Motion carried.

Summer Session Annual Report 2002 - 10 [no discussion]

#### Resource Development - Ken Martin, Chair, and Mike Sells

Mr. Martin reported that the committee enjoyed a good discussion on the economic impact of money available through the Foundation to attract quality students. This discussion will continue at subsequent meetings.

#### SUB/REC Final Design Phase - 11

Trustees were briefed on an updated SUB/REC project timeline during the 9:00 a.m. joint committee session.

Motion 03-06: Mr. Martin moved, seconded by Mr. Sells, that the board delegate authority to the Vice President for Student Affairs and Enrollment Management and the Vice President for Business and Financial Affairs to proceed with the Student Union and Recreation Center Project by approving the site immediately north of Black Hall and west of Chestnut mall, and authorizing the project architects to proceed with final design, including construction documents and bidding. The approval of the site requires the relocation of the power transmission lines. The route for this relocation will be presented for approval at the Board of Trustees meeting March 14, 2003. The completion of this final design phase will be subject to the board's approval of the financial plan for the issuance of a construction bond in early 2004, which will be presented at the May 9, 2003 board meeting. Motion carried.

#### John Wayne Trail Charter Agreement - 14

The John Wayne Trail offers recreation, transportation, cultural and natural system interpretation, land use buffering, wildlife and water quality benefits to the citizens of Kittitas County and the state of Washington. The only break in the trail is through the CWU campus. The university has been asked by the City of Ellensburg to join an effort to plan reconnection of the trail and future enhancements. Bill Vertrees is the university representative on the planning committee.

Motion 03-07: Mr. Martin moved, seconded by Ms. Jones, that the board authorize the board chair to sign the interagency cooperative agreement between the City of Ellensburg, Washington State Parks and Recreation Commission, Kittitas County, and Central Washington University to determine a reconnection route through Ellensburg for the John Wayne Trail. Motion carried.

#### University Semiannual Endowment Investment Report - 12

Vice President for University Relations Paul Baker reviewed the status of current endowment funds and reported that Christine McDermott, successful candidate for the position of Senior Director of Development, had withdrawn her application. The search to fill the position will continue.

Motion 03-08: Ms. Jones moved, seconded by Mr. Martin, that the board approve the following supplemental S&A allocations: \$550,000 one-time allocation for the SUB/REC project, \$6,580 to cover travel for 21 students to attend a GALA-LGBTSA conference and to fund several smaller programs, \$2,131 to cover a salary increase for a classified employee, and \$7,000 for the Equity and Services Council. Motion carried.

#### S&A SUB/REC Allocation - 16

At the February 3, 2003 meeting, the Services and Activites Fees Committee approved an annual allocation of \$850,000 of S&A funds to the SUB/REC Project from July 1, 2003 through the life of the project bonds.

Motion 03-09: Ms. Jones moved, seconded by Mr. Sells, that the board approve the annual allocation of \$850,000 of S&A funds to the SUB/REC Project, effective July 1, 2003 through the life of the project bonds. Motion carried.
