### **Introductions**

### **Approval of Minutes – 1**

**Motion 03-11:** Mr. Reich moved, seconded by Ms. Hazen, that the Board of Trustees approve minutes of their meetings February 13-14, 2003. Motion carried.

## Changes to the Agenda – 2

The following changes were presented: Item 3, Support for Governors Evans and Gardner Higher Education Leadership Project and the Building Washington's Future Act – move to Academic Affairs Committee Report; addition of Item 7, Additional Allocation from Services and Activities Fees; addition of Item 7, Resolution 03-02 Authority to increase West Waivers; addition of Item 8, Faculty Senate Report, addition of Item 17, Full-Time Coaching Appointment – Brian Jensen, Assistant Football Coach.

## Board Chair Report – 3

Mrs. Chaplin reported that she and Mr. Martin attended the final public forum in Ellensburg on the Power Transmission Line Relocation. It was noted that attendance was minimal possibly due to the fact that there are only two routes being considered now. Mr. Reich reported that he, Dr. McIntyre, and Judy Yu attended a joint governing boards work group meeting recently. It was reported that the two and four-year universities are continuing to recognize differences in goals and mission, but are exploring ways to support common goals for all of higher education.

## President's Report

### *Legislative Report – 4*

Government Relations Director Ann Anderson provided a legislative update which included background on the operating, supplemental operating, and capital budgets. The updated briefing sheets were also distributed. These three pieces are our talking points in the Legislature. "Music Education Facility Phase II Tops Capital Request," "Enrollment Tops 2003-05 Operating Budget Priorities," and "Outreach Innovation and Partnerships Increase CWU Service to Washington."

### *Celebrating Special Accomplishments – 5*

Dr. McIntyre introduced Dr. Larry Reintsma, Professor of Accounting at CWU – SeaTac. Professor Reintsma thanked Dr. McIntyre for inviting him to come and stated that he has been a faculty member at CWU – SeaTac since Fall of 1995. He added that he had been working in the business world for 41 years and when he took the position with CWU in 1995, he took a 50% cut in pay. He went on to say that these years with CWU have been the most rewarding years of his working life. He currently teaches Accounting Information Systems, Intermediate Accounting I & II, and Cost Accounting at CWU – SeaTac. He is a highly effective teacher, works well with students, and is dedicated to student learning.

Dr. McIntyre introduced Ms. Melanie Kingham, Instructor in the Department of Teacher Education Preparation at CWU – SeaTac. She also thanked Dr. McIntyre for inviting her to come and say a few words. Ms. Kingham is originally from England and was a preschool teacher there from the mid 1980's through early 1990's. Her primary responsibilities for this academic year at CWU – SeaTac have been practicum supervision and teaching with a focus on Theories of Child Development, Language/Reading Pedagogy, and Math Pedagogy. She has recently had a co-authored article (with Dr. Henry Williams), "Infusion of Technology into the Curriculum," accepted for publication in the Journal of Instructional Psychology. She enjoys her teaching assignments and has just become, this year, a mother for the second time.

Dr. McIntyre then mentioned that the third faculty member that was to be recognized today was unable to attend due to the fact that his son was playing in the State A basketball tournament. Dr. Mark Soelling, Professor of Psychology, has been a faculty member for CWU for 18 years. He has taught at CWU – Steilacoom and CWU – SeaTac in Law and Justice, Early Childhood Education/Elementary Education, Business Education, and Community Health/Chemical Dependency. In addition to teaching, Dr. Soelling works at Western State Hospital as a supervising psychologist in the Adult Psychiatric Unit and directs the psychology internship program. Dr. Soelling says he has enjoyed his 18 years of teaching at CWU immensely. His colleagues say that he is one of the real treasures in our faculty and Center staff say that he always puts the students uppermost in his priorities.

**Relocation of Power Poles – 6**

Mr. Martin congratulated Mr. Corona, the committee, and the entire administration for all their work on this project. The process has been very successful.

**Motion 03-13:** Mr. Martin moved, seconded by Mr. Reich, that the Board of Trustees of Central Washington University delegates authority to the Vice President for Student Affairs and Enrollment Management and the Vice President for Business and Financial Affairs to proceed with the design and construction of the relocation of the PSE transmission lines. The route for this relocation will be from west to east along Dean Nicholson Blvd, turning south between Hogue Hall and the new Music Education Building, to the north side of the town ditch to Maple Street, and then south along the east side of Maple Street to the Fairgrounds. Motion carried.

**S&A Supplemental Budget Allocations – 7**

Supplemental allocations from the Services and Activities Fees Committee were presented for board approval. The allocations include funds to cover a portion of the CWU Readership Program for Spring Quarter 2003 and for Club Senate travel through the remainder of the current fiscal year.

**Motion 03-14:** Ms. Hazen moved, seconded by Mr. Reich, that \$16,645 in S&A supplemental allocations be approved as submitted. Motion carried.

**Resolution Supporting Increasing the West Waiver Authority (Resolution 03-02)**

**Motion 03-15:** Ms. Yu moved, seconded by Ms. Hazen, that the Board of Trustees of Central Washington University adopt **Resolution 03-02** authorizing President McIntyre to increase the West Waiver authority up to \$1,115,000 for the 2003-2004 academic year. Motion carried.

**Faculty Senate – 8**

Faculty Senate Chair Michael Braunstein was unable to attend the meeting, but provided the following written report for the board. At its regularly scheduled meeting on March 5, 2003, the Faculty Senate acted on several issues. They included: an approval of a change to CWU's General Education Program so that it includes an explicit content based writing (W) requirement; a recommendation that an exception be made to section 15.30 of the Faculty Code for Summer Session 2003 that would allow the pro-rating of faculty salaries based on course enrollments; and they identified those individuals that it foresees as likely members of a faculty bargaining unit if a collective bargaining arrangement is sought.
