Board of Trustees Minutes Special/Regular Meetings February 3-4, 2005

Approved March 4, 2005

February 3, 2005

Board members and President McIntyre met at the President's Reception Center for dinner and conversation. No action was taken.

February 4, 2005

Board Committee Meetings (9:00 a.m. to 1:00 p.m.) Trustees convened in committee sessions from 9:00 to 11:00 a.m. and met with Dr. McIntyre from 11:00 a.m. through lunch. Margaret Smith presented her annual audit report at 12:00 p.m. No action was taken.

Introductions

Wayne Quirk, Associate Vice President for Graduate Studies, Research and Continuing Education, introduced Christie Fevergeon, a program support supervisor in the Graduate Studies office who retired December 31, 2004. Dr. Quirk reviewed some of Ms. Fevergeon's contributions to the university's graduate programs over the past 16 years and shared comments about her from faculty, staff, and some of the 3,000 students she assisted during her tenure.

In support of a recommendation to grant postumous emeritus status to Dr. Walt Kaminski, Craig Johnson reviewed Dr. Kaminski's background and contributions to the Industrial and Engineering Technology Department. Susan Donahoe thanked the board for honoring her husband and stated that Walt loved Central and the students he served. Dr. McIntyre noted that Dr. Kaminski advised many students at our university centers and was instrumental in their success.

Approval of Minutes - 1

Motion 05-01: Mr. Reich moved, seconded by Ms. Yu, that the Board of Trustees approve minutes of the regular and special meetings December 2-3, 2004. Motion carried.

Changes to the Agenda - 2

Mr. Martin noted that new backup was available for Item 7, New/Increased University Fees, and moved Item 10, Services and Activities Fees Supplemental Budget Allocations, from action to discussion.

Board Chair Report-3

Mr. Martin reminded the board of two important dates in the next few weeks: February 15 is a statewide joint governing boards/higher education day and May 13 is a joint governing boards session. As liaison from the Board of Trustees, Mr. Martin attended a recent meeting of the Foundation Board and reported that the board is energized and committed.

In June, the Board of Trustees will participate in a topping-off ceremony for the Recreation Center project. It is exciting to see the structure take shape.

The board meets at the CWU-Lynnwood Center on the campus of Edmonds Community College in March and will dedicate discussion to learning more about the centers.

President's Report

Celebrating Special Accomplishments -4

Dr. McIntyre recognized Tony Aronica, a history and anthropology major in the William O. Douglas Honors College, who was one of fifty students nationwide to receive an invitation to attend the Fifth Annual Public Policy and Leadership Conference sponsored by the John F. Kennedy School of Government at Harvard University February 24-27. Mr. Aronica was selected based on his excellent academic standing as well as a demonstrated commitment to public service. The conference helps prepare future leaders for study in public policy.

Dr. McIntyre introduced Josh Schroeder, a music business major at Central Washington University, who was named the Washington State finalist for the John Lennon Songwriter Scholarship. Students must enter an original work to be judged by a panel of distinguished music scholars. Mr. Schroeder's song, titled "Picasso," earned him the privilege of competing with songwriters from across the nation for a \$10,000 scholarship. Following the introduction, Josh performed "Picasso" for an appreciative audience who understood why Mr. Schroeder was the Washington State finalist.

Legislative Report - 5

Central's legislative team—Ann Anderson, Director of Government Relations; Jim Huckabay, CWU Council of Faculty Representatives; Jimmy Berto, CWU Washington Student Lobby representative; and Matt Ackerman, CWUs 2005 student legislative intern—has been working tirelessly to present a unique and refreshing face to legislative policymakers in Olympia. Dave Soltz and Linda Beath have each testified in legislative hearings in support of university priorities. Dr. McIntyre reported that her guest editorial, published in the Tacoma News Tribune on the Sunday before the beginning of the legislative session, became a topic of conversation on the legislative campus and elsewhere. She also joined her community college partners in a series of meetings with newspaper editors in western Washington. The branch campus self-study has dominated committee hearings thus far in the session.

Dr. McIntyre and Vice President Corona will be testifying at upcoming hearings, stressing our main priorities: tuition waiver equity and legislative support for our centers. Our top capital priority is the remodel of Dean Hall.

Board Committees

Academic Affairs - Sid Morrison, Chair

Mr. Morrison reported that Professor Ian Quitadamo presented his research tying student achievement to standards using LifeText, an electronic assessment tool. Students benefit from this assessment tool and it reduces time instructors spend preparing evaluations. Central is a national leader in this area.

Discussion

Summer Session Budget - 6

A budget proposal for Summer Session 2005, approved by the Budget Advisory Committee in January, was reviewed. Summer increases parallel 7% fee increases for the academic year. Processes to determine percentage of increase and tuition projection were discussed. Net summer session revenue will benefit faculty development.

New/Increased University Fees - 7

Fees related to actual costs of necessary materials are included in the list of academic fees. Adjustments to the list are considered twice a year.

Resource Development - Jay Reich

The Resource Development Committee received three reports including Paul Baker's review of Foundation finances, which are improving. He noted that research and development in support of a major capital campaign is continuing. The Foundation Board is aggressive in its efforts to identify individuals willing to support the campaign.

Rich Corona presented an overview of the university's asset growth and noted capital improvements. Mr. Reich noted that the committee enjoyed a good philosophical discussion regarding resource allocation, trend measurement, and the increased burden of growth. Carmen Rahm, Senior Director of Information Technology Services, reviewed the university's plans for wireless internet connections on campus. Eventually, faculty, staff, and students will be able to connect to the internet using wireless service anywhere on campus.

Discussion

CWU/Wenatchee Valley College Higher Ed Center Project - 8

The proposed joint education facility for Central Washington University and Wenatchee Valley College is the university's last joint center capital facility. Supplemental legislative funding has been approved for the \$2.1 million building.

Endowment Investment Report - 9

A endowment investment report for July 1 through December 31, 2004 was presented for review. Results are encouraging.

Student Affairs - Judy Yu, Chair

Ms. Yu expressed appreciation to Vice President Tullos for her strong leadership of the Student Affairs and Enrollment Management Division. Members of the committee heard several reports including an update on the enrollment management plan and efforts to incorporate the plan's goals throughout all divisions. The committee also discussed aging university housing facilities and plans for renovation. We are evaluating ways to meet our needs and remain competitive. A more complete report will be presented in May. Themed learning communities where students gather around a specific program have been very successful. Faculty have been integral to the success of these communities. Efforts are underway to incorporate center students into appropriate student government activities. Student Affairs and Academic Affairs have a strong collaborative relationship.

Changes to the Nondiscrimination Policy - 11

The President's Advisory Council approved changes to the university's nondiscrimination policy July 21, 2004. Proposed changes will modify the nondiscrimination statement to include protection for individuals based on their gender identity and expression—a protection not provided under state or federal law. Redundant sections will be eliminated and access streamlined to the university's internal equal opportunity grievance procedures. The nondiscrimination policy is found in Part 2-2.2 of the university's *Policies Manual* and in Chapter 106-72 WAC. These changes will be presented for action March 4, 2005.

Action

Faculty Code Revisions -12

Proposed changes to the Faculty Code of Personnel Policy and Procedure were approved by the Faculty Senate November 3, 2004, were presented for review. If approved, the changes would require deans to submit lists of faculty eligible for promotion under the provisions of the code by November 1.

Motion 05-02: Mr. Reich moved, seconded by Ms. Romero, that the Board of Trustees approve proposed changes to the Faculty Code of Personnel Policy and Procedure approved by the Faculty Senate November 3, 2004. Motion carried. (Ms. Manring abstalned. Student trustees are not permitted to vote on personnel matters)

Exempt Code Revisions - 13

Proposed changes to the Exempt Employees' Code of Personnel Policy and Procedure were approved by the Exempt Employees' Association using an online ballot. Proposed changes clarify the rules and provide consistency to code language, outline exempt employee responsibilities when there is an emergency closure of the university, and identify new salary ranges and title adjustments for the positions currently classified as vice president's secretaries.

Motion 05-03: Mr. Reich moved, seconded by Mr. Morrison, that the Board of Trustees approve changes to the Exempt Employees' Code of Personnel Policy and Procedure approved by the Exempt Employees' Association. Motion carried. (Ms. Manring abstained. Student trustees are not permitted to vote on personnel matters)

Reports

Faculty Senate -14

Faculty Senate Chair Toni Čuljak reported that the Salary Administration Board process is in the final stages. A summary of their activity will be available soon. The Faculty Senate will be discussing roles and responsibilities with the faculty union. Spring quarter, the Faculty Senate will conduct its biennial assessment of administrators. Dr. Čuljak thanked Dr. McIntyre for her support in providing needed information to aid faculty in conducting the survey. Faculty anticipate their findings will aid the governance process. She also reviewed faculty efforts to provide relief to tsunami victims.

ASCWU Board of Directors - 15

ASCWU President Lucas Westcoat reported that students are engaged in a tsunami relief project to raise money for potable water and sanitation supplies. Students have collected over \$2,500 and funds are still being donated. Tony Aronica, Vice President for Clubs and Organizations, has been instrumental in organizing the project. Another student group is collecting donations for a yard sale with proceeds donated to tsunami relief.

Another priority is the inclusion of center students in student government and student programs. ASCWU officers are currently developing a system to foster that involvement. In addition, the student board is

proactively addressing student concerns regarding the SUB/REC project and senior activities, and they have established a leadership scholarship. Students have testified in legislative hearings regarding tuition waivers.

During the ASCWU report time, Mr. Martin allowed a student group to express a concern regarding the employment contract of a faculty member. Mr. Martin acknowledged that the concern was important to the students and indicated he would examine the issue.

Staff Organizations -16

Employee Council Chair Rob Lowery reported that classified employees appreciated Dr. McIntyre's invitation to submit input regarding areas of distinction at the university. A subcommittee of the Employee Council is currently soliciting input to determine an Employee of the Year for 2004 from among twelve Employees of the Month. The winner should be determined by May. Mr. Lowery reminded the board that most units of the university benefit from the outstanding contributions of classified staff.
