Intellectual Properties Policy – 1

Dr. Quirk explained that the Intellectual Properties Policy was developed over the past 18 months by an ad hoc committee. The policy was considered during faculty collective bargaining negotiations and has been approved by the Teresa Kulik, Academic Affairs Council, President's Advisory Council, and Dr. McIntyre. Collective bargaining negotiating teams accepted the policy January 13, 2006.

Prior university policies involved copyrights and royalties, while the new policy is more in depth, broader in scope, and more reflective of intellectual property issues of the 21st century. The policy also provides a mechanism for protecting the university while providing beneficial incentives for employees. Some small editorial changes will be made to correct typographical errors. The new policy is similar to the policy currently in force at Western Washington University.

Motion 06-01: Mr. Reich moved, seconded by Mr. Frost, that the Board of Trustees approve the Intellectual Properties Policy as proposed with editorial changes. Motion carried.
