**In Memoriam**

Dr. McIntyre mentioned that the university has lost some valued members of the faculty and staff over the last few weeks—Don Black, Professor Emeritus of Education; Dan Jack, Director of Alumni; and Larry Watson, retired university photographer.

**Introductions**

Paul Baker introduced *Jim Armstrong*, Interim Director of Alumni. Mr. Armstrong is active in the community and brings strong experience to the assignment.

Dean Meghan Miller honored *Terry DeVietti* for his 38 years of service to the university in the Department of Psychology. Dr. DeVietti has operated a nationally recognized research program, published and presented widely, and is a former Distinguished Professor—Research award recipient. Thousands of students have been transformed by Dr. DeVietti's critical thinking skills instruction.

Dr. Miller also acknowledged *Phil Tolin*, a faculty member at Central since 1967, for his outstanding contributions. He was among the first experimental psychologists and built a life-long program in scholarship and visual display research. Dr. Tolin has served his department and his college with distinction, currently serving as Associate Dean of the College of the Sciences and Chair of the Department of Law and Justice.

Dean Marji Morgan honored Wes Van Tassel for his 15 years of service to the university and his distinguished career. Dr. Van Tassel managed theatre companies and had professional theatre experience before coming to Central to serve as department chair in Theatre Arts. He has been instrumental in establishing a touring theatre program, a summer master's program for drama teachers, and in the development of the Theatre 101 course. In addition, his book, *Clues to Acting Shakespeare*, is a standard text for theatre performance students.

Dave Darda, Chair of the Department of Biological Sciences, recognized the long and distinguished career of *Barbara Tolin*, who is retiring as department secretary. Ms. Tolin's 38 years and 9 months of service has been spent in the library and, for the last 30 years, in Biological Sciences. Dr. Darda applauded Ms. Tolin's ability to help faculty and students navigate the paperwork required to keep the program running and her friendly, caring attitude.

#### **Approval of Minutes – 1**

Mr. Reich proposed that the board strike "on this personnel matter" appearing on page 5, paragraph 4, line 4 of the minutes.

**Motion 06-19:** Mr. Reich moved, seconded by Mr. Frost, that the Board approve minutes of the March 2-3, 2006 regular and special meetings as amended. Motion carried.

#### **Changes to the Agenda – 2**

Mr. Martin presented the following changes to the agenda: Item 16, additional backup to changes to the Exempt Code; Item 17, addition of a transcript fee and backup; Item 19, current draft of the university's strategic plan.

#### **Board Chair Report – 3**

Trustees held morning committee sessions in the new student union and were impressed with the facility and its usefulness to the university and the greater Ellensburg community. Mr. Martin also commented on recent events he attended—Presidential Speaker Garrison Keillor, the Kittitas Valley Community Hospital foundation dinner in the new student union ballroom, Employee Appreciation Awards, and the Gloria Steinem lecture. Members of the university and Ellensburg communities were present for these events and visibly demonstrated the strong interrelationship of the university and community. On a state level, Mr. Martin joined representatives from other public baccalaureate institutions May 2 at the home of University of Washington President Mark Emmert to discuss the strategic future of higher education in the state of Washington.

#### **President's Report**

##### **Celebrating Special Accomplishments – 4**

Dr. McIntyre asked Dean Meghan Miller to share the accomplishments of two faculty members in the College of the Sciences—Paul Hoskin and Lixing Sun. Professor Hoskin is the recipient of the Max Hey award, an international mineralogy award that is one of the highest honors in the field. He came to Central from the United Kingdom and is noted for facilitating undergraduate student research. Professor Lixing Sun is an outstanding Chinese scholar and student of animal communication. He has published many articles, has made editorial contributions to Chinese journals, and now shares his gifts with Central students.

On behalf of the university, Dr. McIntyre received the Stewardship Award from the State Department of Archeology and Historic Preservation May 2 in recognition of university efforts to preserve and sustain our historic buildings. Ellensburg community members also attended the ceremony to demonstrate their support for the university. In addition, Dr. McIntyre recognized the following individuals for their recent awards: Peter Gries, Washington Music Educators Hall of Fame; CWU Nutrition Team, Nutrition College Bowl champions; Alyson Roy, 2006 Phi Kappa Phi Award of Excellence; CWU graduates Lori Dunn, Renton, and Krista Winn, Port Angeles – National Physical Educators of the Year; CWU graduate Annie Simonis Frederick – 2006 Outstanding Dietitian of the Year Award; CWU graduate Jennifer Boutain Helms, 2006 Recognized Young Dietitian of the Year Award.

## Board Committees

### *Academic Affairs – Sid Morrison, Chair*

Following a report from Dr. Paul Hoskin, committee members examined the Academic Affairs strategic plan. Mr. Morrison reported that the six-year plan is sound and well organized. Accountability and performance measures for the university were also examined. Implementation of the faculty collective bargaining agreement is progressing well.

#### *Action*

##### **New Degree Program [Bachelor of Arts, Film & Video Studies] – 5**

Following a lengthy development process and approval by the Faculty Senate, a proposed interdisciplinary undergraduate program in film and video was presented for approval. It is the first film and video degree program in the Northwest and has generated tremendous student interest.

**Motion 06-20:** Mr. Morrison moved, seconded by Mr. Sells, that the Board approve the Bachelor of Arts, Film & Video Studies with specializations in Critical Studies and Production. Motion carried.

##### **Summer Session 2006 Budget Proposal – 6**

The proposed summer session budget is conservative and reflects programmatic goals for all four colleges through regular coursework, short courses, and workshops. Effective this year, Continuing Education will administer summer session, overseeing revenue generating programs, marketing, and budget development. Faculty development funds generated by summer session and formerly distributed by the Faculty Senate will be delivered in a different way to each faculty member this year. The increase includes a fee for use of the new student union and recreation center applicable to students on the Ellensburg campus.

**Motion 06-21:** Mr. Morrison moved, seconded by Mr. Sells, that the Board adopt the Summer Session 2006 budget as submitted. Motion carried.

### *Resource Development – Leslie Jones, Chair*

Ms. Jones reported that the committee received a status report for the CWU Foundation. Giving levels and the number of donors are increasing. The committee also heard a capital campaign status report and discussed bonding for additional residence halls.

#### *Discussion*

##### **Proposed Quarter Tuition and Fees FY 2006-07 – 7**

The Washington State Legislature recommended a tuition increase of six percent for FY 2006-2007 for resident undergraduate students. Institutions were given tuition-setting authority for resident graduate, nonresident undergraduate, and nonresident graduate students, but the legislature failed to appropriate needed funds. Trustees examined a proposal to increase resident undergraduate tuition and fees for 2006-07 by six percent, resident graduate and nonresident undergraduate students by seven percent, and nonresident graduate students by nine percent. The S&A fee increase for 2006-07 is calculated at six percent for all student categories. The trustees expressed their sympathy to the students and encouraged examination of other revenue sources, including more state support of the cost of higher education.

##### **Auxiliary Services Business Plan – 8**

Although several auxiliary operations are included in the plan, three were presented in detail to members of the committee—the university bookstore, conferencing and catering, and dining services. The university administration has high expectations for the University Store (now the Wildcat Shop), located in the new student union. Competition from the community and from online businesses is keen. Conferencing and catering has a new alignment with the Ellensburg visitor's bureau. Dining Services is making business and managerial changes and changes in services and pricing. Staff are reacting positively to the challenge. Closing two residence halls is impacting student housing, but new facilities could be online by 2009.

**Capital Budget*****CWU Capital Budget Request 2007-09 – 9a***

The board reviewed a proposed ten-year capital plan for the 2007-09 biennium that is similar in detail to the version submitted two years ago.

***Combined Capital Budget Prioritized List 2007-09 – 9b***

The 2003 Legislature passed a law that requires public four-year institutions to develop, in consultation with the Higher Education Coordinating Board and the Council of Presidents, a single prioritized ranking of capital projects. The 2005 Legislature amended the law to change the criteria for ranking the projects. A team of university business officers and budget officers came together for several months to craft the list of projects presented to the board for review. The list may not be modified unless all universities agree.

The law requires that the boards of trustees and regents of the public four-year institutions approve the prioritized capital list before it is submitted to the legislature. The requirement for this combined list does not preclude Central Washington University from submitting or advocating for our own capital list as we have always done. However, the universities have agreed that we will also advocate together for the combined list, and use it as a way to demonstrate the aggregate capital needs of the baccalaureate university system in the state. Our priorities for both the individual and combined lists are the same.

**Operating Budget 2007 – 10**

The proposed 2007 budget is based on this year's budget and is similar to previous years.

**Operating Budget Priorities 2007-09 – 11**

Proposed operating budget priorities for 2007-09 were reviewed and will be presented for action in June.

**State Auditor's Report – CWU Accountability Audit, FY 2005 – 12**

The university accountability audit for 2004-05 was presented to the board for review.

*Action***State Auditor's Reports – CWU System and CWU Athletic Department – FY 2005 – 13**

The board received the State Auditor's reports of the Central Washington University System (Housing and Dining, Services and Activities, Bookstore, and Parking funds), and Central Washington University Athletic Department for the period of July 1, 2004 through June 30, 2005. Both reports were without significant findings.

**Motion 06-22:** Ms. Yu moved, seconded by Mr. Frost, that the Board accept the State Auditor's Reports – Central Washington University System (Housing and Dining, Services and Activities, Bookstore, and Parking Funds), and Central Washington University Athletic Department for the period of July 1, 2004 through June 30, 2005. Motion carried.

**Student Affairs – Jay Reich, chair**

Mr. Reich reported that the committee received reports on the academic performance of athletes, overall average is just under a 3.0 gpa, and that women out-perform men consistently and dramatically. Mr. Reich also inquired if the university has a fundamental institutional alignment to underscore the importance of academics to the athletic program. Members also heard time-to-degree statistics and discussed recruitment issues.

*Action***Summer Student Union Fee – 14**

Students attending Central Washington University during the academic year pay a mandatory \$64.00 per quarter Student Union fee. The business plan adopted by the Student Union and Recreation Center Project Committee in support of the facility approved a \$4.00 per credit fee, up to 12 credits or \$48.00, for summer session student use. The addition of this fee is believed to fairly balance the cost paid by both the summer and academic year students.

**Motion 06-23:** Mr. Reich moved, seconded by Mr. Sells, that the Board approve assessing summer session students \$4.00 per credit, up to 12 credits or \$48.00, for summer session use of the recreation center. Motion carried.

**S&A Supplemental Allocations – 15**

S&A supplemental allocation requests included funds for the Early Childhood Learning Center—Rainbow Center, KCWU radio station, and the ASCWU Board of Directors.

**Motion 06-24:** Mr. Reich moved, seconded by Ms. Yu, that the Board approve the Services and Activities Fees Committee supplemental allocations as submitted. Mr. Frost desented. Motion carried.

**Other Items**

*Discussion*

**Exempt Employee Code Changes – 16**

Proposed changes to the *Exempt Employees' Code of Personnel Policy and Procedure* would clarify language in the Disability Leave Plan and Sick Leave Accrual Plan and reflect changes in the reporting of leave use for employees in the Disability Leave Plan. Other changes would expand the definition of "spouse" and "family member," provide paid leave for public service activities not currently covered by the exempt code, and revise the lower end of the CUPA range for setting salaries. Since many of these changes have a fiscal impact, Dr. McIntyre has requested a cost analysis and financial impact statement.

**Graduation and Application Fee Revisions – 17**

Modest changes to the graduation application fee, diploma request fee, and transcript fee were presented for initial review. These fees have not changed in ten years.

**Drug and Alcohol Policy Revision – 18**

Modifications to the university's drug and alcohol policy that clarify the parameters for marketing or advertising alcoholic beverages on campus were presented to the board for initial review. Changes are consistent with state law.

**University Strategic Plan – 19**

The proposed strategic plan is the result of several forums and the hard work of the synthesizing committee. Comments received during the planning process were positive. People were thoughtful and serious as they examined how our priorities have changed and evolved. Issues regarding each of the six goals were discussed.

**Board of Trustees Meeting Schedule 2006-07 – 20**

The proposed meeting schedule for 2006-07 was presented for initial consideration.

**Board Contracting Authority Resolution – Resolution 06-03 – 21**

**Board Appointing Authority Resolution – Resolution 06-04 – 22**

Editorial changes to the board resolutions delegating appointing and contracting authority were reviewed. Both resolutions will be presented to the board for approval in June.

**Reports**

**Faculty Senate – 23**

Michael Ogden, chair of the Faculty Senate, reported that the Faculty Senate has selected five faculty to serve on the committee to draft a successor document to the *Faculty Code of Personnel Policy and Procedure*. The Senate also approved a new, simpler policy for incompletes and with assistance from center staff and students developed a policy on final exam week. Dr. Ogden reported that the Faculty Senate elected Jeffery Dippmann as chair elect, replacing Greg Cant who resigned his position as Senate chair-elect. The Faculty Senate is also examining the policy on plagiarism.

**Associated Students of Central Washington University/Board of Directors – 24**

Student president Tony Aronica reported that students are pleased and excited about the new student union. Student elections will finalize May 18—student officers and a constitutional change are on the ballot. He also reviewed senior celebration and appreciation activities, drawing special attention to Disability Awareness Week. Students continue to be involved in legislative issues and participate in the newspaper readership program. As day care continues to be an issue of great concern to students, S&A funds have been approved to provide some support. The student board will establish a committee to examine this issue.

#### Staff Organizations – 25

Nancy Howard, chair of the Exempt Employees' Association thanked Dr. McIntyre and the Human Resources Department for the employee appreciation awards.

#### Communications – 26

The trustees received ASCWU resolutions in support of a Health, Counseling and Wellness fee increase and a remodel of the Health and Counseling Building.

#### Consent Agenda – 27

**Motion 06-25:** Mr. Sells moved, seconded by Mr. Reich, that the Board of Trustees receive report items 28 – 30 collectively and approve action items 31 – 40 collectively. Motion carried. (*Mr. Prost abstained; student trustees are not permitted to vote on personnel matters.*)
