#### Presidential Search Process

Following Dr. McIntyre's announcement to the campus community that she plans to retire December 31, 2008, a Presidential Search Plan was drafted and presented to the Board of Trustees for review and approval. The plan includes an outline of the search committee composition; identification of Wendy Bohrson, associate professor and chair of the Department of Geological Sciences, as committee chair, appointment of trustees David Valdez, Keith Thompson, and Sanford Kinzer as committee members; allocation of resources for the search; and an overview of the time frame.

While the Board of Trustees has ultimate control of the process, inclusivity is an important component of a successful search process. The trustees discussed the search process, proposed roles of committee members, and the timeline in detail. Following the discussion, editorial changes involving leadership, budget, and focus were suggested. Proposed adjustments to the president's position description will be integrated into the draft for final approval at the February 1, 2008, board meeting. By concensus, trustees agreed to allow the search committee to select the consultant who will advise the search committee and the board during the search process. The role of the consultant was also discussed.

Motion 08-01: Mr. Morrison moved, seconded by Ms. Jones, that the Board of Trustees approves the presidential search plan and timeline as modified. Motion carried.
