## **Student Protest of Proposed Tuition Increase**

Many students gathered in the board room to protest a proposed tuition increase for 2009-10. In response, Mr. Morrison noted that the trustees have a difficult task responding to 30 percent cuts to the university's budget levied by the legislature. The trustees are committed to preserving institutional quality. Pedro Navarette indicated that students are concerned about support for affordable tuition. Individual students shared their views and encouraged the board to look beyond short-term budget deficits and keep tuition affordable. Mr. Morrison thanked the students and stated that whatever action the trustees take, they will be concerned about students.

## Introductions

Provost Quirk shared information about the three faculty members selected as the 2009 Distinguished Professor of the University: Service—Robert Holtfreter, Accounting; Teaching—Roxanne Easley, History; and Artistic Accomplishment—

Joseph Powell, English. All three will deliver remarks at this year's Honor's Convocation June 11. Matthew Altman, Departments of Philosophy and Religious Studies and director of the William O. Douglas Honors College is the first recipient of the Distinguished Non-Tenure-Track Faculty Award for Teaching.

Sociology Department Chair Hong Xiao reviewed Professor Jack Dugan's long tenure in the department. Kirk Johnson, Interim Dean of the College of the Sciences, praised Dr. Dugan as a strong mentor and advocate for students.

#### Approval of Minutes -1

Motion 09-23: A motion to approve minutes of regular and special meetings March 5-6, 2009 was presented by Ms. Jones and seconded by Ms. Notter. Motion carried.

#### Changes to the Agenda – 2

Mr. Morrison presented the following changes or additions to the agenda: revised backup information for Item 11, Proposed Biennial Operating Budget Request 2009-2011; Item 14, Proposed Annual Operating Budget 2009-2010 – backup information under Item 11; Item 16, Biennial Capital Budget Request 2009-2011; Item 24, Appointment of Associate to the University [also a title revision]; removal of Item 43, Distinguished Service Recognition; and addition of Item 48, Faculty Military Appointment. Item 13, Proposed Quarterly Tuition and Fees for Regular Session AY 2009-2010 was moved to action.

#### **Board Chair Report** – 3

Mr. Morrison reported that he and Dr. Gaudino joined board chairs and presidents from the state's baccalaureate institutions at the University of Washington president's home to discuss the state budget situation and strategies for dealing with short-term and long-term budget issues. Washington State provides a greater percentage of support for higher education than most states, but the trend is for individual citizens to bear more of the cost.

#### **President's Report**

## **Celebrating Special Accomplishments** – 4

President Gaudino presented awards to several people in recognition of their exemplary achievements.

Scott Carlton, Director of Academic Advising, received the 2009 National Academic Advising Association Pacific Northwest Region 8 Advising Administrator Certificate of Merit. Strong professional advising is important to student retention.

The CWU Construction Management Student Team won the 2009 Commercial Division Student Competition, Associated Schools of Construction Region VII, last February in Sparks, Nevada. Team members had 18 hours to develop a bid for a commercial building. Professor Dave Carns and David Kortekaas, president of Sigma Lambda Chi, the construction management national honor society, as well as team members Mike Crook, Garrett Gibson, Mike Yellam, and David Igelmund were present for the award.

Professor Martha Kurtz received the Washington State Higher Education Science Teacher of the Year award.

Sharon Rosell, Physics club advisor, and Travis Petersen, club president, represented the CWU student chapter of the Society of Physics Students (SPS. The CWU chapter won a national outstanding chapter award for 2007-08. CWU physics students have also won national SPS leadership scholarships and research awards in recent years. Dr. Gaudino reported that Mr. Petersen has received a prestigious fellowship to the University of Rochester.

Krissy Tandle-Castaneda is the 2009 NCAA Division II national shot put champion, the first CWU student-athlete to win a national championship at NCAA II level.

#### **Legislative Report** – 5

President Gaudino reported that the legislature reduced the university's full-time equivalent (FTE) targets to 8,477 for 2009-10 and 8,734 for 2010-11. Across the state, enrollment at baccalaureate institutions has been reduced by 9,000 FTE. Central received funding for the Hogue Hall addition and renovation, planning funds for Science Phase II, and some preservation funding. In addition distance education technology resources and learning outcomes will become more centralized and regional universities will now be able to confer honorary doctoral degrees. Dr. Gaudino praised Ann Anderson, Bill Vertrees, and others who represented the university well in Olympia.

Budget details were reviewed at the special meeting (board dinner) April 30.

## Naming Opportunity - Physical Education Building - 26

On behalf of the Development Priorities Committee that he chairs and consistent with the university's naming policy, Provost Quirk requested that the board favorably consider a recommendation submitted by the departments of Nutrition, Exercise, and Health Sciences and Physical Education, School and Public Health [both departments formerly known as Physical Education, Health and Leisure Services] to name the Central Washington University Physical Education Building the Dorothy Purser Hall. Mr. Thompson related a story about Professor Purser from his undergraduate experience at Central that illustrated the positive impact Dorothy Purser had on the lives of students.

<u>Motion 09-25</u>: Based on a recommendation from the Development Priorities Committee, a motion to name the Physical Education Building the Dorothy Purser Hall was presented by Ms. Notter and seconded by Ms. Jones. Motion carried.

#### Authorization for WAC Process - Carpool Permit - 27

The Board of Trustees is required by RCW 28B.35.120 (12) to promulgate rules for the university and authorize initiation of the rulemaking process with the Code Reviser. After the public hearing, the board will receive a request to adopt the final proposed rule at a regular board meeting.

<u>Motion 09-26</u>: A motion to authorize the university's rules coordinator to begin the WAC rulemaking process for the carpool permit rule by filing appropriate notices was presented by Ms. Jones and seconded by Ms. Sandberg. Motion carried.

#### Proposed Quarterly Tuition and Fees for Regular Session AY 2009-2010 -13

Mr. Morrison indicated that the Board of Trustees has labored over the tuition and fees issue because of its impact on costs to families. Over the next year, the university will search for more funding to offset additional tuition increases for the second year of the biennium and provide a higher level of aid to students.

Mr. Thompson read Resolution 09-03 as follows:

BE IT RESOLVED, that the Board of Trustees hereby authorizes a budget for the university, for the first year of the 2009-2011 Biennium, based on the following assumptions. We need a five-pronged approach, all of them equally important.

- (1) An increase in enrollment to 9,200 annual FTE; this opens the door even wider to the addition of students, also somewhat contrary to state recommended levels;
- (2) A 14% tuition increase for 2009-2010 to offset reductions in state subsidy;
- (3) Designation of 11% of the new tuition revenues for institutionally authorized tuition and fee waivers, the source of funds for the waivers to be the university's reserve accounts; and
- (4) Lowering of the maintenance level for fund 149 operating fees to 6%.

BE IT FURTHER RESOLVED, that the Board of Trustees defers to a later time action on the budget assumptions for the second year of the biennium.

BE IT FURTHER RESOLVED, (5) that the Board of Trustees authorizes the university, pursuant to and consistently with Section 601, subsection (7) of Engrossed Substitute House Bill 1244, to implement appropriate plans and strategies to achieve voluntary reductions in full-time equivalent employment and payroll levels.

## Discussion

Use of federal stimulus funds and the university's reserve funds to reduce the impact to individual students was discussed. Trustees expressed their desire to review budgetary targets each board meeting. While a tuition increase is necessary, Mr. Kinzer expressed his concerns about the increase and the deliberation process. Mr. Sweeney thanked the students for their activism and assured them their voices were heard. The board has a responsibility to protect the quality of university's degree programs and mission. A first-generation Central student from 1966-70, Mr. Thompson indicated that he is sensitive to the cost of college education, but felt that the multipronged approach included in the board resolution would enable the university to move forward and firm enrollment. Mr. Morrison stated that the trustees decided to act on the resolution at the May meeting to help students who are planning to enroll and parents who are making decisions for the fall. President Gaudino stated that the recommendation to raise tuition was reached after many hours of searching for other avenues. He also noted that the resolution includes significant cuts to expenditures and a draw against our reserves. Ms. Jones indicated that the board decision was not made in haste; the trustees have examined all options.

<u>Motion 09-27</u>: Mr. Thompson moved to accept the **Resolution 09-03** as presented. Ms. Jones seconded the motion. Following discussion, the motion carried. Trustees Jones, Notter, Sandberg, and Thompson voted for the motion; Trustees Kinzer and Sweeney cast votes against.

#### Reports

#### Faculty Senate - 28

Faculty Senate Chair Mathew Manweller reported that the Faculty Senate is close to revamping the primary instrument for faculty evaluations, Student Evaluation of Instruction. A new instrument for faculty to assess administrators is also in the process of revision. Restructuring the General Education Program is progressing well with several goals already completed. A process to grant non-tenure-track faculty emeritus status is nearly complete, as is a model to combat grade inflation. A senate committee is working on standards for online courses. The Faculty Senate is also taking a lead role in finding efficiencies at the university and resolving time-to-degree issues.

## Associated Students of Central Washington University/Board of Directors – 29

Pedro Navarrete, president of the ASCWU Board of Directors, reported that students will be holding elections for 2009-10 officers very soon. Mr. Navarrete will deliver a State of the ASCWU address June 12 in the SURC Theatre.
