The special meeting was called to order at 1:02 p.m. Chair Morrison asked Ms. Colson to call the roll, which confirmed quorum of the Board was present to transact business.

Action – Series Bond Refinance Sales Approval

Trustee Thompson provided an overview of the process that has been followed during the course of series bond refinance. The university received two bids for these bonds and the winning bid by Robert W. Baird & Co. Inc. was within the fair market rate and will provide a higher savings to the university than was originally expected.

Motion 12-18: A motion that the Board of Trustees of Central Washington University hereby approves [Resolution 12-03], which authorizes System Revenue Refunding Bonds, Series 2012 award to the winning bidder (Robert W. Baird & Co, Inc.) based on a TIC (true interest cost) of 3.406% was presented by Mr. Thompson and seconded by Mr. Erickson. Motion approved.

At 1:25 p.m., Ms. Musselman, Ms. Colson, Vice President Levine, Vice President Clark and Mr. Spitzer excused themselves from the meeting and the Board convened an executive session to discuss a collective bargaining matter excluded from the opening public meetings act. Trustee Reardon entered

the phone call during the executive session and Trustee Erickson exited the phone call. Trustee Reardon asked that the minutes reflect that she was unable to gain access to the telephonic meeting earlier, but that she supported the Board's decision regarding Resolution 12-03.

The Board returned to public session at 1:44 p.m.

Action item – Contract Negotiations

Ms. Holter reported that in October 2007 the Board of Trustees elected to have its contract negotiations for the Washington Federation of State Employees (WFSE) conducted by the governor's designee. After careful consideration, it is now recommended that the Board, through the president, designate university staff to negotiate the contract with the WSFE when such contract negotiations begin in the spring of 2012.

Motion 12-19: A motion that the Board of Trustees of Central Washington University delegates to the president, or his designee, authority to conduct contract negotiation with those collective bargaining agreements covered under RCW 41.80 was presented by Ms. Trottman and seconded by Mr. Liu. Motion approved.

Meeting adjourned at 1:45 p.m.
