Chair Erickson convened the board work session at 1:03 PM. Ms. Schactler took roll to confirm that a quorum of the Board was present. The purpose of the meeting was for the Board to discuss the upcoming presidential search, tentatively slated to begin in late July.

Approval of Agenda

<u>Motion 20-20</u>: Mr. Nellams moved that the Board of Trustees of Central Washington University approve the agenda of the meetings of May 14 and 15, 2020. Mr. Conner seconded the motion, which the board unanimously approved.

Approval of Minutes

<u>Motion 20-21</u>: Mr. Harrington moved that the Board of Trustees of Central Washington University approve the minutes from the meeting of April 9, 2020. Mr. Nellams seconded the motion. The motion was approved.

OPEN PUBLIC MEETINGS ACT (OPMA) BRIEFING

The state's OPMA, established to ensure transparency in government decision-making, requires that public governing bodies deliberate and take actions on hiring and other decisions during open public meetings, including most decisions surrounding the search for a president. The Assistant Attorney General assigned to CWU, Alan Smith, briefed board members on OPMA rules and provided a FAQ sheet for trustees to review in preparation for the upcoming presidential search.

This briefing served as OPMA training for Zabrina Jenkins, whose appointment began in February.

PRESIDENTIAL SEARCH OVERVIEW

CWU has contracted with R. William Funk & Associates for executive searches. The firm is led by its founder and president, Bill Funk, who led a discussion about how presidential searches, the candidate pool, and higher education climate have changed since the last time CWU conducted a presidential search in 2008.

Mr. Funk outlined the search process for the group and explained that the first step will be to develop a search webpage and then begin to hold listening sessions with all key constituents so a leadership statement/prospectus can be drafted to share with prospective candidates.

Appointment of Trustee Search Advisory Committee

Motion 20-22: Ms. Gillis moved that the Board of Trustees of Central Washington University establish a Trustee Search Advisory Committee to be chaired by Trustee Erin Black and to begin immediately to conduct outreach to the university community regarding qualities desired in presidential candidates. Mr. Nellams seconded the motion. The motion was approved.

Endorsement of Preliminary Presidential Search Timeline

<u>Motion 20-23</u>: Mr. Nellams moved that the Board of Trustees of Central Washington University approve the preliminary presidential search schedule to include:

- the immediate start of listening sessions with university stakeholders;
- the recruitment of candidates starting no later than August 1, 2020;
- interviews of candidates in the fall; and
- the conclusion of the search by the end of December 2020

Ms. Black seconded the motion. The motion was approved.

Approval of Search Committee Composition

Motion 20-24: Mr. Conner moved that the Board of Trustees of Central Washington University establish the presidential search committee, comprised of all of the members of the board of trustees and a maximum of five other stakeholders. Ms. Black seconded the motion. The motion was approved.

The additional members of the Presidential Search Committee will be named at the next board meeting.

The work session adjourned at 2:34 PM.

COVID IMPACT AND BUDGET RESPONSE

President Gaudino led a discussion on COVID planning. The status of enrollment and finances for spring quarter were summarized. The plan for summer quarter calls for classes to be predominantly online and a reduction in force for staff. This will include reductions in percent of individual FTE, as well as

furloughs and layoffs in July and August. Cabinet will continuously review the budget and operations in light of the shifting COVID-19 situation. Three planning scenarios for fall quarter were shared with action plans and timelines for each scenario, assuming a 15 percent reduction in state support and a 2.5 percent tuition increase.

Approval of Distinguished Faculty

Since 1977, CWU has honored excellence in faculty teaching, service, and research or creative expression. The recognition, the highest honor for faculty at CWU, is embedded in the Faculty Code (Section III), which establishes awards for Distinguished Faculty and for Non-Tenure Track Faculty. Distinguished Faculty Awards are reserved for individuals who have, at a minimum, served for six years and have worked at least 135 WLU. The awardees are nominated by the Faculty Senate, which may choose not to make an award in any given category. Nominations are authorized by the Board of Trustees.

Recipients of the annual Distinguished Faculty Awards in teaching, scholarship, and service receive a one-time \$2,500 stipend. Recipients of the Board of Trustees Distinguished Faculty Award receive a \$5,000 stipend and a one-quarter release from teaching during the academic year following their award. <u>Motion 20-28</u>: Ms. Black moved that the Board of Trustees of Central Washington University hereby approves Resolution 20-02 honoring Alex Harrington this date May 15, 2020. Mr. Nellams seconded the motion. The motion was approved.

Approval of Promotion and Tenure

State law (RCW28B.35.120) delineates the powers and responsibilities of the Board of Trustees to include employment of all employees, including tenure and promotion and post-tenure review of faculty. Each year the board is asked to consider the recommendations for tenure and promotion, which are the result of the comprehensive process.

Tenure guarantees continuous appointment within a specific university department. Promotion is the movement from one academic rank to the next, typically from assistant professor to associate professor or from associate professor to full professor. Each process is based on departmental, college, and university criteria that include performance in teaching, scholarship, and service. There are five consecutive levels of review: the department personnel committee, the department chair, the college personnel committee, the college dean, and the provost, as outlined in articles 9.2 and 22.2 of the CWU Collective Bargaining Agreement.

Post-tenure review is the evaluation process for faculty who have already been granted tenure with CWU. A review is conducted in the fifth year following the granting of tenure for faculty, and every fifth year thereafter. As with tenure and/or promotion, each evaluation is based on a thorough review by the department personnel committee, department chair, college personnel committee, college dean, and the provost, in accordance with the criteria identified in the departmental, college, and university standards.

This year, 38 faculty submitted professional records to be considered for tenure and/or promotion; 28 were recommended for tenure and/or promotion. Forty-one faculty members submitted professional records for post-tenure review during the regular review cycle.

<u>Motion 20-29</u>: Mr. Conner moved that the Board of Trustees of Central Washington University hereby approves faculty tenure, promotion and post tenure review as recommended by the Provost this day May 15, 2020. Mr. Nellams seconded the motion. The motion was approved.

Approval of BA STEM Teaching

The Department Science Education proposed the Bachelor of Arts STEM Teaching Program major to replace the current STEM Teaching Program minor. The STEM Teaching Program prepares students to teach science, mathematics, or computer science at the middle or high school levels. Undergraduate students who successfully complete the STEM Teaching Program, a STEM major degree, and Washington State assessments, qualify for the Washington State Residency Teaching Certificate.

<u>Motion 20-30</u>: Mr. Nellams moved that the Board of Trustees of Central Washington University hereby endorses the recommendation of the Faculty Senate (Motion No. 19-57) and hereby approves the Bachelor of Arts STEM Teaching Program this day May 15, 2020. Mr. Nellams seconded the motion. The motion was approved.

Approval of Consent Agenda

The formal recognition for our faculty and staff is contained in the consent agenda.

<u>Motion 20-31</u>: Mr. Nellams moved that the Board of Trustees of Central Washington University hereby approves the consent action items submitted May 15, 2020. Ms. Jenkins seconded the motion. The motion was approved.
